Sub: To lodge FIR against owner and driver namely Bhandu Singh Chatri (32 yrs) S/O Lt. Baldev Singh Chatri of Rajpati, PS- Arsha, Dist- Purulia of one Mahindra B-275 DI Tractor bearing Reg. No. WB55B/1085, having Eng. No. RKB2EAN1158 & chassis no. MBNABAEXPKRB07002 along with trolley (loaded with approx 60 CFT sand)

Sir,

In producing herewith, One Mahindra B-275 DI Tractor bearing Reg. No. WB55B/1085, having Eng. No. RKB2EAN1158 & chassis no. MBNABAEXPKRB07002 along with trolley. Today on 19.02.2022 while on Spl. Mobile duty vide C.C No. 371 Dtd. 19.02.22 acting on source information, I PSI Avijit Mondal of Arsha PS along with (i) C/-1015 Rittwick Kar and (ii) C/- 1002 Arif Mohammad both of SAP 7<sup>th</sup> BN camp at Arsha PS we found 01 (one) tractor along with trolley loaded with sand at Hensla morh under Arsha PS at 12.15 hrs. Seeing the Police Party the driver namely Bhandu Singh Chatri (32 yrs) S/O Lt. Baldev Singh Chatri of Rajpati, PS- Arsha, Dist- Purulia of said tractor tried to flee away, but we apprehended him. I asked the Bhandu Singh Chatri of said tractor to produce valid document in support of carrying sand, but he could not produced as such documents. Hence, I seized the above noted tractor along with trolley. I also arrested the driver namely Bhandu Singh Chatri (32 yrs) S/O Lt. Baldev Singh Chatri of Rajpati, PS- Arsha, Dist- Purulia after issuing memo of arrest and brought the said tractor and the driver to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid documents and violating the Govt. order.

Hence, I do hereby lodge this complaint against the owner and driver namely Bhandu Singh Chatri (32 yrs) S/O Lt. Baldev Singh Chatri of Rajpati, PS- Arsha, Dist- Purulia of above noted tractor along with the trolley for investigation.
