I, Subhankar Biswas, Dy.SP (U/T), O/C Arsha PS do hereby lodged this FIR as soumoto against the drivers and owners of seized tractor having Reg. No. (i) WB55B/1886, (ii) WB55B/3979, (iii) WB55A/4989, (iv) WB55A/4965 & (v) WB55B/2487 along with trolleys loaded with sand (60 CFT each). Today on 21.02.2022 while my Spl. Mobile duty vide C.C No. 386/22 Dtd. 21.02.22 with (i) C/-361 Sanjoy Paramanik (ii) C/-480 Kumar Amar both of SAP 7th BN camp at Arsha PS and (iii) C/146 Maheswar Singh Sardar of Arsha PS we reached at Mishirdih morh under Arsha PS at 18.15 hrs, we conducted raid at Mishirdih morh and found that 05 (five) tractors along with trolleys loaded with sand were coming from Satra side. Seeing the Police party, those persons leaving the tractors (loaded with sand in the attached trolleys) at Mishirdih morh, fled away. Police rushed to the tractors and detained the said tractors. Police searched the said tractors and found that the tractors is loaded with sand and also searched surrounding but could not trace out the persons & drivers of said offending tractors. Hence, I seized the above noted tractors along with trolleys and brought the tractors to Arsha PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand and violating the Govt. order they are doing such illegal activity.
