No. WB55B/0771 (ii) Nabin Mahato (25 yrs) S/O Dharani Mahato of Beldih, PS- Arsha, Dist- Purulia of seized tractor having Reg. No. WB55B/2288 and (iii) Tinkar Singh Sardar (30 yrs) S/O Bholanath Singh Sardar of Jhariadih, PS- Arsha, Dist- Purulia of seized tractor having Reg. No. JH09AC/2185 and the owner of above noted tractor along with trolleys (each trolley loaded with approx 60 CFT sand). Sir,

In producing herewith, 03 (three) tractors having Reg. No. (i) WB55B/0771 (ii) WB55B/2288 & (iii) JH09AC/2185 along with trolleys (each trolley loaded with approx 60 CFT sand). Today on 23.02.2022 while on Spl. Mobile duty vide C.C No. 403 Dtd. 23.02.22 acting on source information, I ASI Rajib Chakraborty of Arsha PS along with (i) C/-694 Nekibuddin Khan of Arsha PS (ii) C/- 480 Kumar Amar of SAP 7th BN camp at Arsha PS (iii) C/984 Krishnapada Hembram of do and (iv) 963 Sourav Santra of do, we reached at Beldih Bridge Ghat under Arsha PS at 13.55 hrs, we conducted raid on the Bank of River Kansai under Arsha PS and found that 03 (three) Tractors along with trolleys attached with by a hinge was present at Beldih Bridge Ghat on the Bank of River Kansai. Some persons were loading sand in the attached trolleys of said tractors. Seeing the Police Party the drivers namely ((i) Shib Shankar Gope (23 yrs) S/O Mansaram Gope of Beldih, PS- Arsha, Dist- Purulia of seized tractor having Reg. No. WB55B/0771 (ii) Nabin Mahato (25 yrs) S/O Dharani Mahato of Beldih, PS- Arsha, Dist- Purulia of seized tractor having Reg. No. WB55B/2288 and (iii) Tinkar Singh Sardar (30 yrs) S/O Bholanath Singh Sardar of Jhariadih, PS- Arsha, Dist- Purulia of seized tractor having Reg. No. JH09AC/2185 tried to flee away, but we apprehended them. I asked them to produce valid document in support of carrying sand, but they could not produced as such documents. Hence, I seized the above noted tractors along with trolleys. I also arrested the drivers namely (i) Shib Shankar Gope (23 yrs) S/O Mansaram Gope of Beldih, PS- Arsha, Dist- Purulia (ii) Nabin Mahato (25 yrs) S/O Dharani Mahato of do and (iii) Tinkar Singh Sardar (30 yrs) S/O Bholanath Singh Sardar of Jhariadih, PS- Arsha, Dist- Purulia of seized tractor having Reg. No. JH09AC/2185 after issuing memo of arrests and brought the said tractors and the drivers to Arsha PS. As there is every reason to believe that the drivers and owners of the said tractors with ill motive were transporting sand illegally without any valid documents and violating the Govt. order.

Hence, I do hereby lodge this complaint against the owners of seized said tractors and drivers namely (i) Shib Shankar Gope (23 yrs) S/O Mansaram Gope of Beldih, PS- Arsha, Dist- Purulia (ii) Nabin Mahato (25 yrs) S/O Dharani Mahato of do and (iii) Tinkar Singh Sardar (30 yrs) S/O Bholanath Singh Sardar of Jhariadih, PS- Arsha, Dist- Purulia of above noted tractors along with the trolley for investigation.
