I diarized the information vide Arsha P.S G.D.E No- 1296 dated-26.02.2022 and accordingly informed my superiors and as per their direction myself along with night mobile officer PSI Avijit Mondal and force of Arsha PS with Govt. Vehicle No WB-68X/2741 left for those places to work out the information. At about 06.55 hrs on 26.02.2022 we reached at Kantadih morh and found leaflets were pasted at the wall of Puara G.P Office. I seized the leaflets 03 Nos. from that place. After that I seized leaflets 03 Nos. from that place. The contents of all the leaflets are same as above.


Thereafter I went to Herodih Morh at about 08.25 hrs and found some leaflets pasted on the tea shop of Lal Gorain. After that I seized leaflets 04 Nos. from that place. The contents of all the leaflets are same as above. From there I went to Mishirdih morh at about 09.25 and found same poster were pasted at the tea shop of Pandab Kumar at Mishirdih morh, I again seized the leaflets nos. 04 from the above place. From there I went to Naya morh at about 10.35 hrs and found some leaflets pasted on the wall of Medical shop of Bhim Kumar. After that I seized leaflets 03 Nos. from that place.

Thereafter I went to Kadampur morh at about 11.25 hrs and found some leaflets pasted on the wall of rest house of Bus stop. After that I seized leaflets 03 Nos. from that place.

I took photograph of each and every leaflets before seizure. All leaflets are written in Bengali script. All the seizures were duly signed by my accompanying officer and force as seizure witnesses and duly labeled separately. This is to be noted that since the contents of the leaflets are related to CPI Maoist no local person agreed to give signature on seizure list as seizure witnesses in fear as the area was highly LWE affected in the past.

From the above such leaflets it was clearly indicated that the miscreants created a group and with criminal conspiracy collected leaflets and make them prepared for the assigned work as well as engaged themselves in waging war against the State knowing it fully well and there by committed an offence u/s-121/121A/124A/120B IPC.





So we started interrogating different villagers from where the leaflets were found. We searched other adjoining villages also but did not found any other leaflets, posters etc.

During interrogation of villagers and through source information it was revealed that (1) Amrit @ Satyaban Mahato S/O Arun Mahato of Vill- Haranama, PS- Arsha, Dist- Purulia (2) Anil Tudu S/O Lt. Surendranath Tudu of Vill- Bulantanr, PS- Arsha, Dist- Purulia (3) Nagen Tudu S/O Lt. Rajkishore Tudu of Bulantanr, PS- Arsha, Dist- Purulia (4) Madhusudan Majhi S/O Lt. Suna Majhi of Vill- Mahultanr, PS-Arsha, Dist- Purulia (5) Sambhu Majhi S/O Lt. Mariram Majhi of Vill- Nalakocha, PS- Arsha, Dist- Purulia (6) Sambhunath Soren (Majhi) S/O Lt. Sufal Soren (Majhi) of Mahultanr, PS- Arsha, Dist- Purulia (7) Subrata Mahato S/O Ananda Mahato of Haranamam, PS- Arsha, Dist- Purulia and (8) Umesh Ch. Gope S/O Garjan Gope of do are involved in this. So, we started searching them. Our source informed that the miscreants are may be their respected houses. We searched the house of the above notes accused at their houses and able to arrest 06 of them namely (1) Amrit @ Satyaban Mahato S/O Arun Mahato of Vill-Haranama, PS- Arsha, Dist- Purulia (2) Anil Tudu S/O Lt. Surendranath Tudu of Vill- Bulantanr, PS-Arsha, Dist-Purulia (3) Nagen Tudu S/O Lt. Rajkishore Tudu of Bulantanr, PS- Arsha, Dist-Purulia (4) Madhusudan Majhi S/O Lt. Suna Majhi of Vill- Mahultanr, PS- Arsha, Dist- Purulia (5) Sambhu Majhi S/O Lt. Mariram Majhi of Vill- Nalakocha, PS- Arsha, Dist- Purulia (6) Sambhunath Soren (Majhi) S/O Lt.
