Sir,

In producing herewith the 02 (Two) accused persons namely (1) Lalit Mandal (48 Yrs), S/O- Lt. Rup Sanatan Mandal, (2) Santosh Mura @ Handka (27 Yrs), S/O- Lt. Ajambar Mura both of Vill- Rabidih, PS-Baghmundi, Dist- Purulia along with seized articles (1) 10 (Ten) liter ID Liquor containing in a white plastic jerican & 10 (Ten) Pcs Plastic Glasses, (2) 10 (Ten) liter ID Liquor containing in a white plastic jerican & 08 (Eight) Pcs Plastic Glasses which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 01.02.2022 during my mobile duty as per source information I along with force 1. C/856 Mustakfizur Mondal, 2. C/733 Md. Haidar Ali both of SAP 11th Bn. Camp at Baghmundi P.S, Dist-Purulia reached at Rabidih village at 19:05 hrs and found that the above noted persons is selling I.D liquor in front of Lalit Mandal's house premises under Baghmundi P.S, Dist Purulia. On demand they failed to produce any valid document from competent authority in respect of stocking & selling of liquor. I seized (1) 10 (Ten) liter ID Liquor containing in a white plastic jerican & 10 (Ten) Pcs Plastic Glasses, (2) 10 (Ten) liter ID Liquor containing in a white plastic jerican & 08 (Eight) Pcs Plastic Glasses from their possession U/S- 67 B.E. Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witness and accused persons. Hence I arrested the above noted persons at 19:15 hrs. & 19:55 hrs after maintaining all formalities and guidelines regarding arrest. I offered them for medical treatment but they refused.

The above noted arrested accused persons namely (1) Lalit Mandal (48 Yrs), S/O- Lt. Rup Sanatan Mandal, (2) Santosh Mura @ Handka (27 Yrs), S/O- Lt. Ajambar Mura both of Vill- Rabidih, PS-Baghmundi, Dist- Purulia committed an offence U/S- 46 A (c) B.E. Act 1909 for unauthorized possession and selling of ID Liquor from their sole possession.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused persons under proper section of law and arrange its investigation.
