Sir,

In producing herewith one accused person namely Prahllad @ Palku Mura (60 Yrs), S/O-Lt-Baghu Mura of Vill-Bara-Dava, PS-Baghmundi, Dist-Purulia along with seized articles i.e 1) 10 (Ten) liter ID Liquor containing in a white plastic Jeri can & 2) 10 (Ten) Pcs Plastic Glasses which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 18.02.2022 during my special mobile duty as per source information I along with force 1. C/747 Amit Kumar Dhara, 2. C/900 Saikat Sarkar both of SAP 11<sup>th</sup> Bn. Camp at Baghmundi P.S, Dist-Purulia reached at Bara-Dava village and found that the above noted person is selling I.D liquor in his house premises at Bara Dava village under Baghmundi P.S, Dist Purulia. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. I seized 1) 10 (Ten) liter ID Liquor containing in a white plastic Jeri can & 2) 08 (Eight) Pcs Plastic Glasses from their possession U/S- 67 B.E. Act which were seized under proper seizure list duly signed by the witnesses. All seized articles were labeled properly in presences of witness and accused persons. Hence I arrested the above noted person at 19:15 hrs after maintaining all formalities and guidelines regarding arrest. I offered him for medical treatment but he refused.

The above noted arrested accused person namely Prahllad @ Palku Mura (60 Yrs), S/O-Lt-Baghu Mura of Vill-Bara-Dava, PS-Baghmundi, Dist-Purulia, PS-Baghmundi, Dist- Purulia committed an offence U/S- 46 A (c) B.E. Act 1909 for unauthorized possession and selling of ID Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the above noted accused person under proper section of law and arrange its investigation.
