I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sri Sumanta Kumar, S/O- Kalashashi Kumar of village - Karru, P.O. - Uttamdih P.S- Bagmundi Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 08/02/2022 at about 01:05 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundih CCC along with 1. Abdul Hasib, ACM 2. Subhasis Mahato, Sr. O.E. entered the premises of Sri Sumanta Kumar, S/O Kalashashi Kumar of village - Karru, P.O. - Uttamdih P.S- Bagmundi, Dist- Purulia and found Sri Sumanta Kumar was enjoying electricity unauthorizedly drawing power from the nearest L & MV line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.1 KVA. As Sri Sumanta Kumar S/O- Kalashashi Kumar committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Abdul Hasib, ACM 2. Subhasis Mahato, Sr. O.E. The inspection team left the premises at 01:15 p.m.
