Purulia along with seized approx 10 (ten) litters (ID liquor) with a plastic Jarican (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:35 hrs. I received a credible source information that one Mayur Singh Sardar (37 yrs) S/O- Lt. Bhajahari Singh Sardar of Vill- Berhyadi, P.S.- Balarampur, Dist. Purulia is selling ID liquor without any valid license from his Grocery shop at Daldiri more, P.S-Balarampur, Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for at Daldiri more to work out the source information. Thereafter we reached at Daldiri more at about 19:05 hrs as per source information, I along with force held raid in the Grocery shop of Mayur Singh Sardar.

During search with the help of accompany with force, we found that the said person is selling ID liquor at Daldiri more. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said ID liquor. Accordingly, I seized the said ID liquor (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle (600 ML) as a sample. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(c) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(c) B.E. Act against the arrested accused person namely Mayur Singh Sardar (37 yrs) S/O- Bhajahari Singh Sardar of Vill- Berhyadi, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(c)B.E. Act and arrange for its investigation.
