I, SI Sanjay Diger along with force return to PS and brought under seizure 01 (one) seized Tractor attached with trolley having Engine No DC1024/SBH10833, Chassis No-NBNAU52AHLTH15208 loaded with approx 100 cft. sand. The fact in brief is that today (18.02.2022) I along with force namely i) C/1304 Dhananjoy Mondal ii) C/2622 Kartick Ghosh were performing special night mobile duty at Balarampur P.S area vide Balarampur P.S GDE No- 756 Dated- 18.02.2022 in consonance Balarampur P.S C.C No- 780/22 Dated-18.02.2022. During my special night mobile duty I received a credible source information that one Tractor was lifting & carrying sand illegally and coming from Nimdih side through Dantia which is Jharkhand Purulia Border & coming towards Balarampur. Subsequently, I informed you and as per your order, I placed Naka at Berma village more on NH-32 to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one tractor was proceeding towards Balarampur. Consequently, we intercepted the said Tractor at Naka checking point at about 03:45 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police, driver of offending Tractor fled away leaving the Tractor on road before Naka checking point. We tried to apprehend him but failed. We waited for reasonable time but none came to spot. It was ascertained that the driver of the tractor loaded the said sand in cahoots with the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and they had been running a clandestine business. So it is reasonable to belief that he in cahoots with the owner of the offending tractor procured the said sand from River at Nimdih P.S side area Jharkhand by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the vehicle tractor attached with trolley having Engine No DC1024/SBH10833, Chassis No- NBNAU52AHLTH15208 loaded with approx 100 cft. sand under proper seizure list in presence of witnesses duly signed by them. Thereafter, I brought the said tractor to Balarampur P.S compound.

Under the above facts and circumstances kindly take lawful action against the Owner & driver of the said offending tractor as they committed offence U/S 379/411/414 of the IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957
