I would like to state here that on 09.02.2022 at 22:25 hrs in course of my evening mobile duty received a telephonic information from local CVF personnel of Ruchap village that a tension is growing on over the issue of Saraswati idol immersion in between Shanti Club of Ruchap village and Mahamaya Club of Rapkata village and also fighting with each other's including both the ends of man & women of Ruchap village. After receiving that information myself with accompanying force rushed

to spot at Ruchap village to control the situation. After reaching at Ruchap village Hari Mela at about 22:55 hrs and found two unruly mob with huge gathering from both club members and supporters including women's were fighting with each other's by lathi and tangi, near approx 200 persons including women. On seeing the Police personnel the mob is became more furious and Gherroud the Police party and obstruct the Police personnel to deter their official duty. On seeing that situation somehow I informed the entire fact to O/C, Balarampur P.S and requested him to send reinforcement to tackle the situation. After reaching the reinforcement officers & forces at about 23:55 hrs we all approached the said unruly mob to disbursed from this place, but they did not pay any heed and started chanting and use filthy languages upon the Police personnel and saying that "আজ পুলিস কে বাগে পায়েছি। আজ এদের কে মেরেই ফেলবো, থানা ফিরতে দিবো নাই।" all on a sudden the said unruly mob started brick beating upon the Police party and started assault the Police with Lathi, Tangi and hand Axe. As a result myself along with SI Bhudeb Ch. Kuiry, ASI Dulal Sing Sardar, C/3118 Mithun Das, C/144 Shaktipada Murmu, C/2311 Swapan Mahato receiving serious injuries on their persons in which SI Bhudeb Ch. Kuiry & ASI Dulal Sing Sardar with his fractured facial referred to Purulia Deben Mahato Govt. Medical College & Hospital after primarily treated at Banshgar C.H.C and the said unruly mob ransacked the Police vehicle bearing Reg. No- WB56C/8739 by pleating stones & khapra. Thereafter we pushed them & disbursed the mob from there and arrested the above notes accused persons after maintaining all formalities. On being interrogation arrested accused persons confessed their guilt and they stated that the following persons namely 1) Bhramar Sing Sardar S/O-Maheswar Singh Sardar along with his younger brother as well as his family members namely 2) Smt.
