

In producing herewith 08 arrested accused persons namely 1. Biswajit Mahato (44Y) S/O Lt. Sudhannya Mahato of Vill-Madhupur 2. Ranjit Mahato (36Y) S/O-Guhiram Mahato of Vill-Mourang 3. Joyprakash Mondal (52Y) S/O-Lt. Chandeswar Mondal of Vill-Block Mor Bandwan 4. Jitendramath Rohida (42Y) S/O-Shatrughna Ruhidas of Vill-Madhupur 5. Sk. Aliram (24 Y) S/O-Sk. Ali Hossain of Vill-Bandwan 6. Chandra Mohan Mahato (37Y) S/O- Mangobinda Mahato of Voll-Kumirdih all are of PS-Bandwan, Dist-Purulia 7. Samir Mahato (40Y) S/O- Ajit Kr. Mahato of Vill-Dighi, PS-Boro, Dist-Purulia 8. Goutam Kr. Gorai (30 Y) S/O Lt. Prafulla Gorai of Vill-Kumargram, PS-Komalpur, Dist-East Singhbhum JH. I beg to state that on (01.01.22), I was directed to find out whether wearing of mask by the public has been properly maintained in Bandwan Chwak Bazar or not and also to observe Lock down protocol at night from 11.00 PM to 05.00 AM. Accordingly, I along with (1) C/1224 Gajan Murmu (2) C/1463 Santimoy Ghosh both of Bandwan PS, Dist-Purulia had been to Bandwan Chwak Bazar at about 23:05 hrs and found that a gathering appeared at Bandwan Chwak Bazar, none of them were wearing mask. On seeing Police they tried to escape from the grip of police party but some failed to escape due to efficient effort of Police. On being asked they disclosed their identity as noted above.

In this pandemic situation of CORONA Virus/COVID-19 the above noted persons violated the order duly promulgated by government through public servants and through media by strolling, riding without mask instead of following the COVID rules of wearing mask and not to stroll after 11.00 PM as there is complete lockdown after 11.00 PM to 05.00 AM. They are creating annoyance in that locality & violated Govt order No. 753/XXII-ISS/2M-22/2020, Dtd-31.01.22 for complete restriction measure. So, I arrested them for Disobedience of order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest. I informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act and released them on bail. At prima facie there were sufficient evidences to secure their detention. All the process was done in between 23:05 hrs to 23:20 hrs.

Therefore, I pray a specific case may kindly be lodge against above noted arrested accused persons as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated the rule.
