Respected Sir,

In producing here with arrested accused person namely Kartick Ch. Hansda (age-47 yrs) S/O-Lt. Balai Hansda of Vill. Chirudih Radhanagar, P.S. Bandwan, Dist. Purulia along with seized Illicit Distill liquor & other appliance utensils (details of seized articles are mentioned in attached seizure list), I beg to submit that today i.e. on 18/02/22 at about 17:35 hrs. I received a credible source information while I was engaged in Spl. Mobile duty that one person namely Kartick Ch. Hansda S/O-Lt. Balai Hansda of Vill. Chirudih Radhanagar, P.S. Bandwan, Dist. Purulia is preparing, stocking and selling Illicit Distill liquor without any valid license from his back side of dwelling house at vill. Chirudih Radhanagar, P.S. Bandwan, Dist. Purulia. Accordingly, I along with force (C/1572 Badal Mahapatra C/59 Alhad Rajak both are of Bandwan P.S., Dist-Purulia) vide Bandwan P.S. C.C. No. 412/22 Dtd: 18/02/22 left for Chirudih Radhanagar village to work out the said source information and held raid at the back side of his dwelling house where the above mentioned accused person preparing, stocking and selling Illicit liquor. During search with the help of accompany force, we found that the said person is preparing and stocking Illicit Distill liquor for sell. Being asked, he disclosed that all liquor has been prepared/ stocked for the purpose of sell. On demand, he failed to produce any valid documents/ License in respect of preparing, stocking and selling of Illicit Distill liquor. Accordingly, I seized all the Illicit Distill liquor & other appliance utensils (details in attached seizure list) which have been used to prepare Illicit Distill liquor after preparing proper seizure list duly signed by the witnesses. One liter Illicit Distill liquor has been kept & labeled as sample bottle. **Approx 10 liters Illicit Distill liquor has been seized.** Then, I arrest him after preparing proper arrest memo as he committed offence U/S-46A (a) (b) (c) B.E. Act 1909 and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a Cog. case may kindly be started **U/S-46A (a) (b) (c) B.E. Act 1909** against the arrested accused person namely **Kartick Ch. Hansda (age-47 yrs) S/O-Lt. Balai Hansda** of Vill. Chirudih Radhanagar, P.S. Bandwan, Dist. Purulia and arrange for its investigation.
