In producing here with the arrested accused persons namely (1) Deepak Mahato (20 yrs approx) S/O-Laxmiram Mahato (2) Laxmiram Mahato (40 yrs approx) S/O-Lt. Bhushan Mahato both are of Vill-Sirka, PS-Bandwan, Dist-Purulia (3) Sk. Ayub Ali (27 yrs approx) S/O-Sk. Yakub Ali of Vill-Natundih, PS-Ranibandh, Dist-Bankura (4) Rasid Alam (47 yrs approx) S/O-Lt. Firoj Khan @ Alam of Vill+PS-Garhnokha, Dist-Rohtas Sasaram Bihar A/P-Durganagar, Birgaon, PS-Urla, Dist-Raipur Chattishgarh (5) Pankaj Yadav (20 yrs approx) S/O-Sunil Yadav of Vill+PS-Kuransariya, Dist-Buxar Bihar (6) Umashankar Ray (52 yrs approx) S/O-Lt. No. BR-03GA/8118, Mahindra Bolero Pick up van bearing Reg. No. WB-23E/6106, Mahindra Bolero Pick up van bearing Reg. No. WB-23F/3616 and 40 (fourty) cattle (14 pcs Cow, 03 pcs buffalo & 23 pcs calf), I do hereby submitting written complain to the effect that on 18.02.22 at 20.05 hrs, I received a source information about illegal transportation of animals. Accordingly, I along with force left PS to work out the information after obtain kind permission from O/C Bandwan PS. I reached at Jamuna Bridge on Bandwan - Kulupal (SH-05) road at about 20:25 hrs and as per information, I intercepted 10 (ten) persons in four vehicles bearing Nos. 1. JH-05CB/2105 (3 persons) 2. BR-03GA/8118 (3 persons) 3. WB-23E/6106 (1 person) 4. WB-23F/3616 (3 persons) (all are Mahindra Bolero Pick up van) were loaded with total 40 (forty) cattle (14 cow, 03 Buffalo & 23 Calf) animals of different size which were coming from Bandwan side. On searching, we found that (a) 17 (seventeen) cattle in Pick up van No. JH-05CB/2105 out of which 02 (Two) cows and 15 (fifteen) Calfs, (b) 07 (seven) cows and Buffalo in Pick up van No - WB-23E/6106 out of which 03 (three) Buffalo and 02 (two) cows & 03 (three) Calfs (c) 09 (nine) cows in Pick up van No - WB-23F/3616 out of which 06 (six) cows and 03 (three) Calfs (d) 07 (seven) cows in Pick up van No - BR-03GA/8118 out of which 4 (four) cows and 03 (three) Calfs are loaded and was carrying in cruel manner within a short space of the vehicles. I asked them to produce relevant documents in respect of the vehicles and cattle such as live stocks permit. But, they failed to produce any valid documents in respect of the vehicles and cattle. They stated incoherently manner and from their statements, it is reason to believe that they have procure the vehicles and cattle by means of theft or fraudulently and was trying to conceal those. They also confessed that they are doing this offence habitually since long. Being asked, all the above noted accused persons disclosed their identity as noted above. But, their identity could not be verified as they failed to produce any photo ID proof documents. Accordingly, I seized 04 (four) offending Pick up vans having Reg. Nos. JH-05CB/2105, BR-03GA/8118, WB-23E/6106, WB-23F/3616 (all are Mahindra Bolero Pick up van) with 40 (fourty) cattle (14 pcs Cow, 03 pcs buffalo & 23 pcs calf) after preparing proper seizure list duly signed by the accused persons and accompanied Police persons because of unavailability of the local people.

Then, I arrested all the above noted 10 (ten) accused persons after gathering sufficient evidence against them.

I therefore pray that a case may kindly be started against accused (1) Deepak Mahato (20 yrs approx) S/O-Laxmiram Mahato (2) Laxmiram Mahato (40 yrs approx) S/O-Lt. Bhushan Mahato both are of Vill-Sirka, PS-Bandwan, Dist-Purulia (3) Sk. Ayub Ali (27 yrs approx) S/O-Sk. Yakub Ali of Vill-Natundih, PS-Ranibandh, Dist-Bankura (4) Rasid Alam (47 yrs approx) S/O-Lt. Firoj Khan @ Alam of Vill+PS-Garhnokha, Dist-Rohtas Sasaram Bihar A/P-Durganagar, Birgaon, PS-Urla, Dist-Raipur Chattishgarh (5) Pankaj Yadav (20 yrs approx) S/O-Sunil Yadav of Vill+PS-Kuransariya, Dist-Buxar Bihar (6) Umashankar Ray (52 yrs approx) S/O-Lt.
