Sub: Prayer for lodged FIR

Sir,

In producing here with 04 (Four) arrested persons namely (i) Uttam Nayak (30 Yrs) S/o- Prafulla Nayak of Jagannathpur, PO- Gamharia, PS- Adityapur, (ii) Hari Nayak (36 Yrs) S/o- Jawaharlal Nayak of Vill- Rayabsa, PO+PS- Gamharia both of Dist- Saraikela Kharswan, Jharkhand (iii) Nakul Majhi (28 Yrs) S/o- Dasarath Majhi of Vill- Bamnidih (iv) Biswajit Saren (35 Yrs) S/o- Lula Saren of Vill- Khawasdihi both of PS- Barabazar, Dist- Purulia along with memo of arrest and other relevant papers.

I beg to state that on 01.02.2022 evening myself along with C/- 1484 Tushar Kanti Mandal & C/- 1481 Godadhar Biswas were performing evening mobile as well as special raid duty in c/w Simultaneous Drive under Barabazar PS area. This refers to Barabazar PS GDE No- 48 Dtd. 01.02.2022. Accordingly, we left PS for performing evening mobile duty. At around 23.15 hrs we found that some persons were moving aimlessly without any valid reason near Barabazar Block Office morh under Barabazar PS without any reason and not wearing any face masks. We detained the above noted persons with the help of force and CV who were on duty at that place.

I introduced myself and asked for their identity. They disclosed their identity as noted above. On interrogation these persons stated their identification but failed to give any satisfactory answer for their such type of act for violating govt orders (Night Curfew between 11.00 P.M to 05.00 A.M). I asked them the reason for not wearing face masks in Covid-19 pandemic situation. They failed to explain any valid reason for non-wearing of masks in spite of the government order in public places. Their negligent act is likely to spread infection of disease, dangerous to the life of human beings. All 04 (Four) persons also failed to give satisfactory answers for their such type of movement in an indiscipline manner. They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus / COVID-19. They are creating annoyance to the society & violating the govt order **vide Memo No- 753/XXII-ISS/2M-22/2020 Dtd. 31.01.2022 of the Govt. of WB.**

Accordingly, I arrested them for Disobedience to order duly promulgated by a public servant; after maintaining all rules of arrest. Issued memo of arrest, informed them & their relatives regarding the ground of arrest i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by public servant). At prima facie there was sufficient evidence to secure their detention. They also violated the norms of disaster management. The arrest was made at 23.35 hrs.

After that myself left for PS. On arrival at PS I typed this letter of complaint at our PS computer and submitted it to I.C Barabazar PS through duty officer SI Uttam Chatterjee for taking necessary action as per law. I handed over all the relevant papers, Arrest Memos.
