Sub: Complaint against Arjun Mandal (32 Yrs) S/o- Bhadari Mandal of Vill- Sindri, PO- Fatepur Sindri, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Arjun Mandal (32 Yrs) S/o- Bhadari Mandal of Vill- Sindri, PO- Fatepur Sindri, PS- Barabazar, Dist- Purulia and seized one bags inside one plastic jarecane loaded with approx 15 (Fifteen) liters I.D liquors (Mahula) on which 500 ml seized as sample from said jarecane as per enclosed seizure list.

I, ASI Dipak Das of Barabazar PS do here by lodge this complaint against Arjun Mandal (32 Yrs) S/o- Bhadari Mandal of Vill- Sindri, PO- Fatepur Sindri, PS- Barabazar, Dist- Purulia. I beg to state that on 17.02.2022 myself along with C/- 1494 Manas Kumar Mukherjee & C/- 975 Ashoke Kr. Saharay were left for special mobile duty vide Barabazar PS GDE No- 995 Dtd. 17.02.2022. During special mobile duty at about 23.05 hrs I received an information that one person was carrying I.D liquor and going towards Laka village from Sindri village. I was there to verify the credibility of that information and immediately informed to the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with forces had been to the said place to work out the information. At about 23.25 hrs I detained one person at Sindri village morh near Rammandir under Sindri G.P who was carrying one bag. Seeing the Police party the alleged person tried to flee away, but I apprehended him with the help of the Police party and on being searched I found that the person carrying one bag inside one plastic jarecane loaded with approx 15 (Fifteen) liters I.D liquors (Mahula). On demand, he failed to produce any valid documents / License in respect of carrying I.D liquors (Mahula). On being asked he confessed his guilt and stated that he carried the I.D liquors (Mahula) with intent to sell to make his own profit. He disclosed his identity as Arjun Mandal (32 Yrs) S/o- Bhadari Mandal of Vill- Sindri, PO- Fatepur Sindri, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for carrying of I.D liquors (Mahula). Accordingly, I seized one bags inside one plastic jarecane loaded with approx 15 (Fifteen) liters I.D liquors (Mahula) after preparing proper seizure list and put label on the seized articles in presence of witnesses and on which 500 ml of I.D liquor taken as sample which were also duly labeled by me and also took signature of the accompanying witness on seizer list and label as well as accused person also. The seizure and label was done in between 23.35 hrs and 23.55 hrs. Thereafter, I arrested the accused person namely Arjun Mandal (32 Yrs) S/o- Bhadari Mandal of Vill- Sindri, PO- Fatepur Sindri, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. Accordingly, informed him and his relatives regarding the ground of arrest over mobile. The arrest was made on 18.02.2022 at 00.05 hrs.

Under the above fact & circumstances I therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Arjun Mandal (32 Yrs) S/o- Bhadari Mandal of Vill- Sindri, PO- Fatepur Sindri, PS- Barabazar, Dist- Purulia under proper section of Law.
