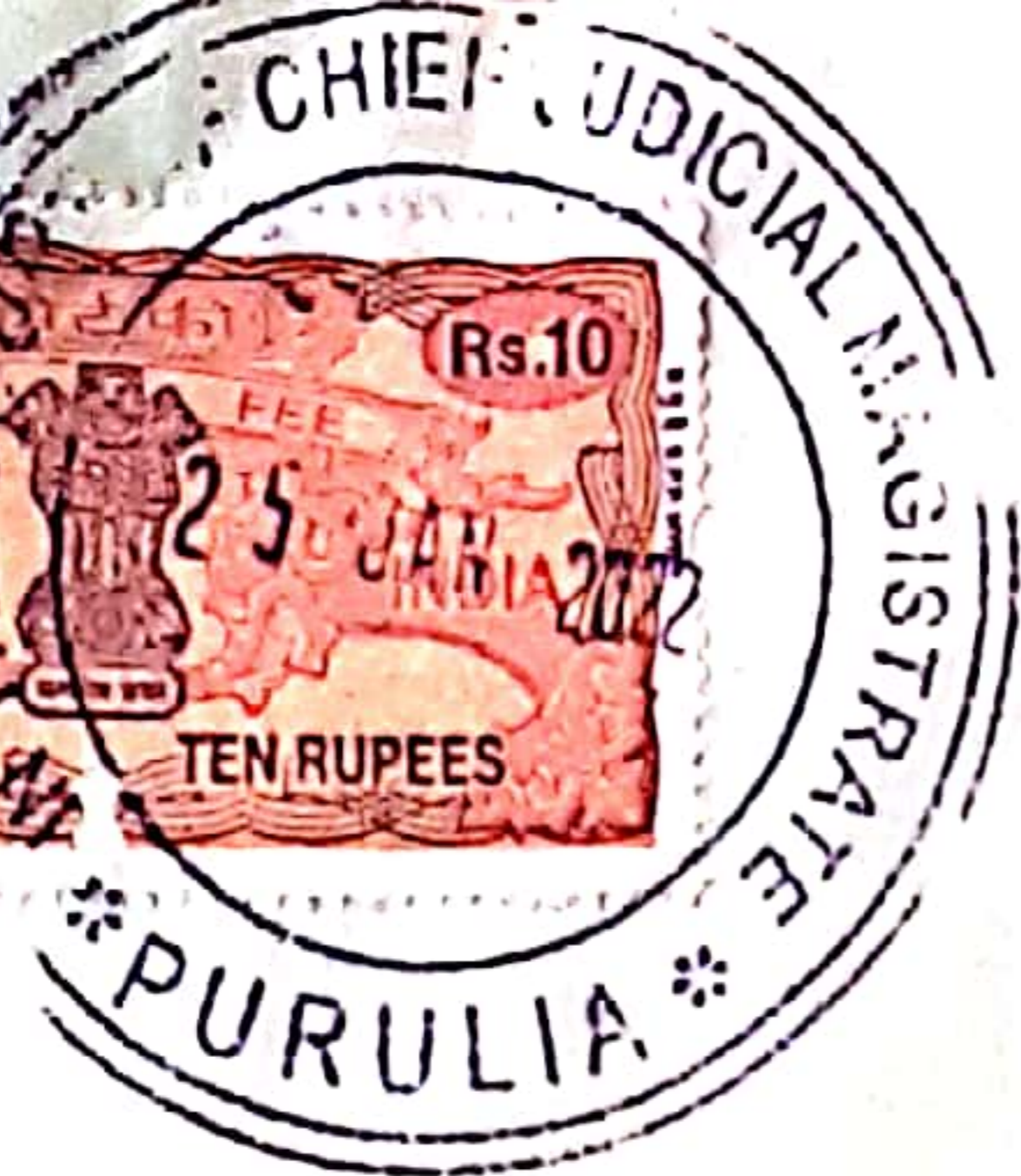

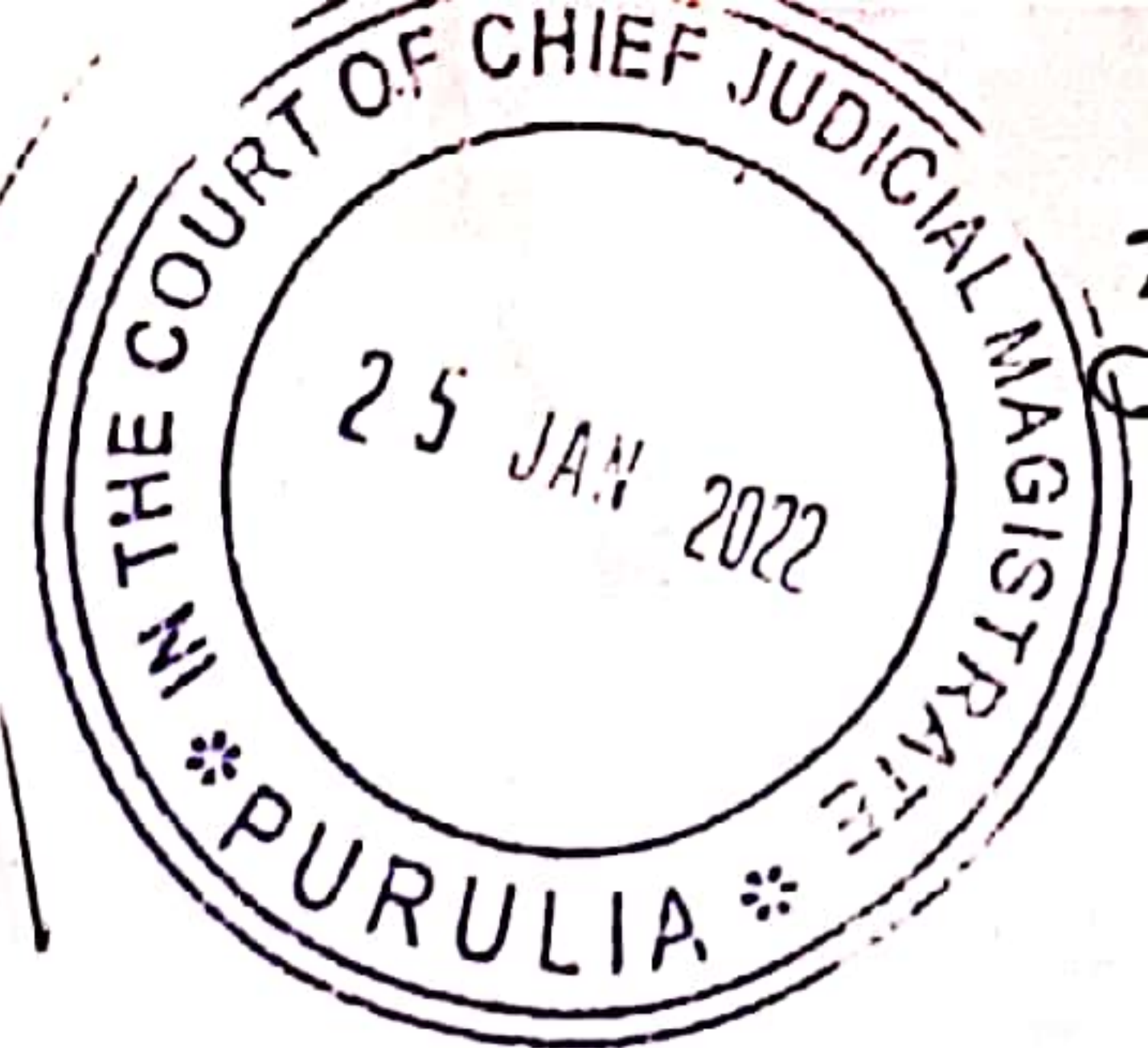

Most respectfully begs to state as follows:-

1. That the complainant/petitioner is the socially legal married wife of the accused no.1 namely Sahadeb Tudu of Vill.Jharnakocha, P.S.Barabazar, Dist.Purulia and marriage in between complainant and accused no.1 has been solemnised on 4th day of Jaistha 2016 calendar year as per social rights and customs prevail in their community
2. That at the time of marriage parents of the petitioner complied to pay all the demand of the family of the accused and as the accused persons are very greedy persons they are not satisfied with the dowry given at the time of marriage and the accused persons always demanding further additional dowry from the petitioners parents.
3. That since after three months from the date of marriage petitioner subjected to illbehave and physical as well as mental torture by the accused persons, i) Sahadeb Tudu, ii) Dharamdas Tudu (Bhasur) and iii) Sushila Tudu (mother-in-law) conspired with each other started to physical assault off and on they demanded further dowry though both Sahadeb Tudu and Dharamdas Tudu <sup>are</sup> school teacher and Sahadeb Tudu now posted at Ankhapura H. S. School, Mohanpur, Dist. Midnapur.

4. That in the meantime one son namely Saikil Tudu has been born after three years from the date of marriage and petitioner kept mump on the hope that peace may come at the family by the laps of time but all in vain.
5. That on 15.11.2021 at village Jharnakocha near about 4 p.m. all the accused persons inflicted physical assault to your petitioner and it was so horrible the petitioner admitted before the Bari B.P.H.C. and treated by the duty doctor and since then petitioner residing at her father's house at village Jagda under P.S.Boro, Dist.-Purulia.
6. Here also be it mentioned that all the accused persons snatched the lepping baby namely Saikil Tudu and threaten if petitioner stayed at Vill.Jharnakocha they will killed her alongwith lappingg baby .
7. That being no other alternative petitioner took shelter at her father's house and informed the matter before the Boro P.S. but no action was taken then petitioner informed the matter to local P.S. but all in vain and finally informed the matter to S.P.Purulia on 3.1.22 but till date no legal action taken.
8. That being the deserted lady petitioner have no other alternative but to take the shelter of sec.156(3) to booked the wrong dower to punished them as per pro-
