Sub: Complaint against Brihaspati Mahato (22 Yrs) S/o- Banamali Mahato of Vill- Bagalbandh, PS- Barabazar, Dist- Purulia to start a specific case under proper section of Law.

Sir,

In producing here with arrested accused person namely Brihaspati Mahato (22 Yrs) S/o- Banamali Mahato of Vill- Bagalbandh, PS- Barabazar, Dist- Purulia and seized (i) One ten liters Plastic Jaricane containing approx 06 (Six) Liters (ID liquors) (ii) 02 (Two) plastic bottle containing approx 04 (Four) liters (I.D Liquors) in which 500 ml taken as sample as per enclosed seizure list.

I, SI Basudeb Acharya of Barabazar PS do here by lodge this complaint against Brihaspati Mahato (22 Yrs) S/o- Banamali Mahato of Vill- Bagalbandh, PS- Barabazar, Dist- Purulia. I beg to state that today 23.02.2022 at about 18.35 hrs during my evening mobile duty I received telephonic information that one person was selling I.D liquor in his house at Bagalbandh village. I was there to verify the credibility of that information and immediately informed the I.C Barabazar PS. As per direction of I.C Barabazar PS myself along with C/- 1182 Santosh Kumar Mahato & C/- 1187 Samar Kanta Maity had been to the said place by Govt. vehicle to work out the information. At about 19.05 hrs I detained one person at Bagalbandh village under Bansbera G.P who was selling I.D liquors in his house. Seeing the Police party the alleged person and customers were tried to flee away, but I apprehended the seller with the help of the Police party and on being searched I found that the person stoking (i) One ten liters Plastic Jaricane containing approx 06 (Six) Liters (ID liquors) (ii) 02 (Two) plastic bottle containing approx 04 (Four) liters (I.D Liquors) for selling. On demand, he failed to produce any valid documents / License in respect of stoking or selling of I.D liquors. On being asked he confessed his guilt and stated that he was stoking the ID liquors with intent to sell to make his own profit. He disclosed his identity as Brihaspati Mahato (22 Yrs) S/o- Banamali Mahato of Vill- Bagalbandh, PS- Barabazar, Dist- Purulia. He also admitted that he has no license or any authorization for selling of I.D liquors. Accordingly, I seized (i) One ten liters Plastic Jaricane containing approx 06 (Six) Liters (ID liquors) (ii) 02 (Two) plastic bottle containing approx 04 (Four) liters (I.D Liquors) after preparing proper seizure list and put label on the seized articles in presence of witnesses in which 500 ml taken as sample which were also duly labeled by me and also took signature of the accompanying witness on seizer list and label as well as accused person also. The seizure and label was done in between 19.20 hrs and 19.30 hrs.

Thereafter, I secured arrest the accused person namely Brihaspati Mahato (22 Yrs) S/o- Banamali Mahato of Vill- Bagalbandh, PS- Barabazar, Dist- Purulia after preparing Memo of Arrest & after observing all other formalities regarding arrest as per Cr.PC and NHRC guideline. I informed him regarding the ground of arrest and his relatives regarding arrest. The arrest was made on 23.02.2022 at 19.35 hrs.

Under the above fact & circumstances I, therefore, pray before you that a specific case may kindly be registered against the arrested accused person namely Brihaspati Mahato (22 Yrs) S/o- Banamali Mahato of Vill- Bagalbandh, PS- Barabazar, Dist- Purulia under proper section of Law.
