- 1...That the Complainant is a residence of Village-Sindri, P.O. Fatepur, P.S. Barabazar, District - Purulia and within the jurisdiction of the Ld.Court.
- 2...That on 24.1.22. at about 12.00 to 12.30 hrs. electricity staffs of Sindri Anchal came near the house of the complainant to repair the electric line. One poll has installed near the house of the complainant and the next poll is about 20/30 mts. from the said poll. After repairing the electricity problem while the staffs were going., the accused persons being armed with lathi, ballam, etc. came near the house and threatened the staffs. The Staffs did not raise any objection because the accused persons were not in a normal stage. On hearing halia the complainant came out from his house . Thereafter the accused persons threatened the complainant with dire consequences. The accused persons gharowed the complainant restrained the complainant with an intention to cause hurt. On being protest the accused persons assaulted the complainant, abused the complainant and female members with filthy languages . The said persons also insulted the daughter of the complainant that they will kidnap the daughter etc.
- 3..That the complainant went to Sindri out post to lodge a complain, and also submitted the written complain which was received by the police officer on the same day but the Police officer did not put his signature of the copy of the complainant .The duty officer also assured that he will visit the place and will take steps.
