Most respectfully sheweth:-

1...That the complainant is a residence of Village Sindri, P.O.Fatepur, P.S.Barabazar, District Purulia and within the jurisdiction of Sindri Anchal.

2...That Plot no.2033 stands in the name of the complainant in R.O.R. There are other share holders but the above-named accused persons have no share, title and interest in plot no.2033. ^{The plot is a pond.}

3...That on 5.2.22. at about 10.30 to 11.00 A.M. the share holders arranged for catching fishes in the said pond accordingly the fishermen caught fishes. The fishes were distributed between the share holders, and after taking their shares most of the share holders left the pond. The share of the complainant was stayed in the ail. When the complainant was arranging to collect the fishes with the help of witnesses all on a sudden the accused persons forming an unlawful assembly in furtherance of common intention came to place with a view to cause hurt to witness no.3 because the witness and his wife had lodged diaries before O/C Barabazar P.S. and Sindri out post. and thereafter the accused persons threatened the complainant and witnesses with dire consequences by saying to withdraw the diaries otherwise the accused persons will not allow the complainant and witnesses

to collect fishes. On being denied the accused persons used filthy languages and snatched the fishes by ~~snatching~~ showing tangi, lathi etc. Due to fear and to save the life from the hands of accuseds the complainant did not protest. The accused persons took away the fishes for which the complainant has suffered a loss of Rs. 4000/- The Xerox copy of R.O.R. is attached herewith.

4... That the complainant informed the matter to local But post at Sindri. The duty officer assured that he will take steps but he did not take any legal steps nor visited the place and/or interrogated the complainant and others.

5... That the accused persons are very dangerous and desperate in nature and also influenceable persons. Due to ~~of~~ fear the witness ~~was~~ unable to depose against the accused persons and the accused persons have managed the police officers too.

6.. That on being aggrieved the complainant submitted an application before S.P. Purulia on 9.2.22. but till date no action has taken. The complainant thought that Police will take steps hence the delay in lodging the complainant.
