## To The Inspector In-Charge Barabazar Police Station Dist- Purulia

Sub: Prayer for lodged FIR.

Sir,

In producing herewith one dumper, bearing Registration No- WB 03C 7532 loaded with approx 400 c.f.t sand, seizure lists, seized article.

I beg to state that on 15.02.2022 myself along with C/- 897 Umapada Dhalla and C/- 677 Syed Julhar Ali were performing night mobile duty vide Barabazar PS GDE No-812 Dtd. 14.02.2021, Command certificate no:- 453/22 Dtd. 14.02.2022 with Govt vehicle bearing Registration No- WB 56B 8008. When we were going towards Sakhari side and reached near Sakhari morh under Barabazar PS at about 01.05 hrs found one dumper coming from Purulia side towards Barabazar and seen the Police party driver of the said vehicle kept at the dumper ar the side of road fled away Sakhari morh, under Barabazar PS. I along with force rushed to the spot and found one dumper bearing Registration No- WB 03C 7532 loaded with (approx) 400 c.f.t. sand and standing beside the pitch road. We searched for driver and owner of the dumper but none turned up.

I conveyed the same to I.C Barabazar PS. I thoroughly search the nearby 2 KM areas in radius after placing guard for the vehicle. After that I came back and search the driver cabin of the dumper for papers of the vehicle. All my efforts ended in smoke. I found only one expired road E challan for sand vide no 1814345/S/21-22/140220221016/PS with dt of issue 14/2/22 dt 8.10 AM and validity till 14/2/2022, 8.10 PM.

Accordingly I seized the dumper loaded with sand about 400 c.f.t approx bearing Reg No- WB 03C 7532 along with the E road challan as noted above—under proper seizure list which has been duly signed by witness. The seizure was done in between 01.45 hrs and 02.15 hrs.

Held an enquiry about the matter and I went up Tokoriya area in search of the driver. So far information collected it is crystal clear that the driver and the owner of the said dumper, in a trade of illegal trading of sand the sand. They were carrying the sand by illegal means with intent to make unlawful profit by unlawful collection of sand through illegal manner by removal of mines & minerals.

By this way they violated the regulation of procurement of sand. As such there is every reason to believe that the driver and owner of the said dumper with ill motive were transporting the sand illegally without any valid document in support of carrying sand. They violated the Govt. orders. As such they were doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of said dumper.
