Subject: Complaint against Tarani Kanta Saren (48Yrs), S/O- Sishubandhu Saren of Vill- Bargoria, PS - Boro, Dist - Purulia to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accused person Tarani Kanta Saren (48Yrs), S/O- Sishubandhu Saren of Vill- Bargoria, PS - Boro, Dist - Purulia with seized 16 (Sixteen) sealed bottles in containing 600 ml each bottles styled as 'Dil khus' and 01 (one) bottle seized as sample from there as sell proceed from the possession of above noted accused which were seized under proper seizure list.

I beg to submit that today (18/02/2022) during my Special mobile duty in between 19:15 hrs to 19:45 hrs acting on a secret source information I apprehended the above noted person in his house at Bargoria village and found that above noted person illegally stocked and selling 'Dil khus' to local public. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents / License in respect of said illicit spirit which was kept in his house. Accordingly I seized 16 (Sixteen) sealed bottles in containing 600 ml each bottles styled as 'Dil khus' and 01 (one) bottle seized as sample from there as sell proceed under proper seizure list in presence of witnesses, which is enclosed herewith. As such he was arrested at 19.55 hrs u/s 46 A (C) B.E and during arrest the ground of arrest was duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to the arrestee. Out of seized 'Dil khus' wine 600ml taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd. Tarani Kanta Saren (48Yrs), S/O- Sishubandhu Saren of Vill- Bargoria, PS - Boro, Dist - Purulia violate section 18(i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention and he committed offence u/s 46 A (C) B.E. Act. 1909.

It may note here that during raid (1) C/353 Ganesh Ch. Roy, (2) C/ 974 Dilip Ghosh accompanied me.

Under the fact and circumstanced I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Tarani Kanta Saren (48Yrs), S/O- Sishubandhu Saren of Vill- Bargoria, PS - Boro, Dist - Purulia.
