



 - 2. That the complainant has filed a suit before the Id. Civil Judge Senior Division, Purulia along with a injunction application in which Id. Court has been pleased to pas an order of statusquo in respect of the property described in schedule below.
 - 3. That the complainant duly served notice as per law but the accused persons after receiving the notice x trying to damage the seasonal crops and the complainant raised objection, but the accused persons did not pay any heed to it.
 - 4. That on 08.01.2022 the accused persons has tried to cut away some paddy over the paddy land and some seasonal crops over the gora portion of the property at about 11 A.M. and the complainant raised objection to the illegal act of the accused persons but they did not pay any heed.
