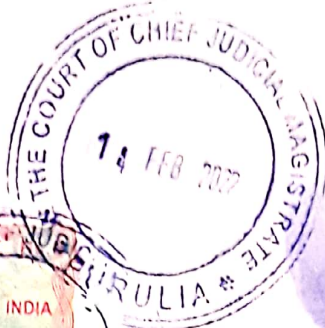

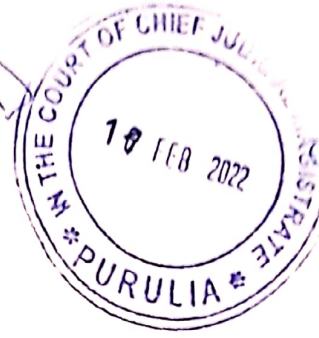

1. That the property recorded in R.S. khatian no. 36 and 334 bearing R.S. ~~1111~~ plot no. 1940, 1939, 1944 and 1945 situated in mouza Furdaha within p.s. Boro and within the jurisdiction of this Court.
2. That the complainant has filed a suit before the Id. Civil Judge Senior Division, Purulia along with a injunction application in which Id. Court has been pleased to pass an order of statusquo in respect of the property described in schedule below.
3. That the complainant duly served notice as per law but the accused persons after receiving the notice & trying to damage the seasonal crops and the complainant raised objection, but the accused persons did not pay any heed to it.
4. That on 08.01.2022 the accused persons has tried to cut away some paddy over the paddy land and some seasonal crops over the gora portion of the property at about 11 A.M. and the complainant raised objection to the illegal act of the accused persons but they did not pay any heed.
5. That the complainant submit that the accused persons have damage the crops amounting to Rs, 10,000/=
6. That the complainant submit that the complainant being in peaceful possession of the property and & the accused persons have got no right to trespass the

the property described in schedule below.

7. That the accused persons have committed an offence u/s . . . . .

8. That the complainant submit that the complainant has submitted an application before the Boro p.s. and also to S.P. Purulia as required under the law.
