Sub: Prayer for lodged FIR,

Respected Sir.

In producing herewith one Mini Dumper having Reg. No- WB 55A/ 7192 loaded with approx 250 c.f.t sand, seizure lists, seized articles.

I beg to state that on 16.02.2022 myself along with (i) C/1442 Shib Sankar Singha, and (ii) C/3024 Rabin Karmakar, were performing night mobile duty vide Boro PS GDE No. 650 Dtd- 16.02.2022, C.C. No- 428/2022, Dtd: 16.02.2022, with Govt. vehicle Reg. No. WB 42S/ 4996. When we were going towards Burudih More side and reached near Burudih More under Boro PS at about 01.25 hrs found one mini dumper coming from Manbazar side towards Bandwan and seeing the Police party driver of the said vehicle kept at the mini dumper are the side of road fled away Burudih More under Boro PS. I along with force rushed to the spot and found one mini dumper bearing Reg. No. WB 55A/7192 loaded with approx 250 c.f.t sand and standing beside the pitch road. We searched for driver and owner of the dumper but none turned up.

I conveyed the same to O/C Boro PS. I thoroughly search the nearby 2 KM areas in radius after placing guard for the vehicle. After that I came back and search the driver cabin of the dumper for papers of the vehicle. All my efforts ended in smoke. I found no paper / documents relating to vehicle or loaded sand.

Accordingly I seized the mini dumper loaded with sand about 250 c.f.t approx bearing WB 55A/ 7192 under proper seizure list which has been duly signed by witness. The seizure was done in between 02.15 hrs to 02.45 hrs on 17.02.2022.

Held an enquiry about the matter and I went up Burudih area in search of the driver. So far information collected it is crystal clear that the driver and the owner of the said dumper, in a trade of illegal trading of sand the sand. They were carrying the sand by illegal means with intent to make unlawful profit by unlawful collection of sand through illegal manner by removal of mines & minerals.

By this way they violated the regulation of procurement of sand. As such there is every reason to believe that the driver and owner of the said dumper with ill motive were transporting the sand illegally without any valid document in support of carrying sand. They violated the Govt. orders. As such they were doing illegal business activities.

Under the above facts and circumstances, I pray before you that kindly take needful action against the driver and owner of said dumper.
