Sub: Request for lodging F.I.R. against arrested accused person Basudev Mahato (28 yrs.) S/O Banku Bihari Mahato of Vill- Hariharpur, PS – Kenda, Dist – Purulia.

Sir,

In producing herewith arrested accused Basudev Mahato (28 yrs.) S/O Banku Bihari Mahato of Vill- Hariharpur, PS – Kenda, Dist – Purulia along with seized one motorcycle (Hero HF Delux) having registration No WB 56R/8702

I beg to report that today I ASI Narayan Mukharjee along with C/2539 Ashis Duley and HG/1535 Pravas Ruhidas all of Hura PS were performing mobile duty vide Hura PS C.C No – 301/22 dtd. 01.02.2022 and while we reached at Lalpur Traffic More under Hura PS area at about 18:05 hrs, We found One Hero HF Deluxe Motor Cycle was going from Hura side towards Purulia side with rash and negligently. We tried to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could be able to stop him at Madhuban more On NH60A road under Hura PS, Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he also failed to produce any driving license. It is known from online searching that his wife namely Chhumumoni Mahato is the registered owner of the said motorcycle.

Accordingly, I seized the motor cycle having registration No- WB 56R/8702, Engine No – HA11ESL9J05415 & Chassis No – MBLHAW148L9H07578 (Hero HF Deluxe) with a view to prosecute him U/S 279 IPC and 181/184 MV Act 1988. The whole process of seizure was completed in between 18:25 hrs and 18:45 hrs. I also arrested him at 18:55 hrs. as he violated sec 279 IPC and 181/184 MV Act 1988 in presence of police party. His family member was also informed over cell phone about the ground of arrest.

Hence I pray that a specific case U/S 279 IPC and 181/184 MV Act 1988 may kindly be initiated against accused Basudev Mahato (28 yrs.) S/O Banku Bihari Mahato of Vill- Hariharpur, PS – Kenda, Dist – Purulia and arrange its investigation.
