Finding no other alternative I seized and labeled 1). 10 (ten) sealed bottle of DILKHUSH (Country Spirit) containing each 600 ml 2). 05 No of empty bottle of DILKHUSH 3). 10 no of plastic glasses in between 18.15 hrs and 18.35 hrs from the possession of said person under proper seizure list duly singed by the witnesses and also arrested him at 18:45 hrs. U/S 47 BE Act after followed all formalities as given by NHRC and Ld. Supreme court.
