In producing herewith one arrested accused. person namely Akash Gope (32 yrs) S/O- Asananda Gope of Vill-Layadih, PS- Hura, Dist- Purulia along with all seized articles & papers. I beg to submit that today i.e on 18.02.2022 during my Special mobile duty at 18.00 hrs at Keshargarh more acting on a source information myself along with force had been to village Layadih at 18.05 hrs and held raid in the house of the above noted person and found that he is keeping/selling Country Spirit which was kept in his own position. On demand he failed to produce any valid document in respect of keeping and selling of said liquor. On asked he could not be able to give any satisfactory answer about the keeping and selling the same. Finding no other alternative I seized and labeled 1). 10 (ten) sealed bottle of DILKHUSH (Country Spirit) containing each 600 ml 2). 05 No of empty bottle of DILKHUSH 3). 10 no of plastic glasses in between 18.15 hrs and 18.35 hrs from the possession of said person under proper seizure list duly signed by the witnesses and also arrested him at 18:45 hrs. U/S 47 BE Act after followed all formalities as given by NHRC and Ld. Supreme court .

The above noted arrested accd. namely Akash Gope (32 yrs) S/O- Asananda Gope of Vill-Layadih, PS- Hura, Dist- Purulia has committed offence u/s 46 A(c) B.E.Act. 1909 for unauthorized possession and sale of country spirit.

Under the fact and circumstances I pray before you that a case u/s 46 A (c) B.E.Act. 1909 may kindly be started against Akash Gope (32 yrs) S/O- Asananda Gope of Vill-Layadih, PS- Hura, Dist- Purulia and arrange for its investigation.
