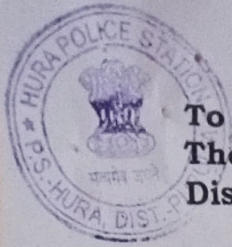

**Sub:** Request for lodging F.I.R. against arrested accused person Susanta Ganguli (26 yrs.) S/O Jaharlal Ganguli of Vill- Ladhurka, PS - Hura, Dist - Purulia.

Sir,

In producing herewith arrested accused Susanta Ganguli (26 yrs.) S/O Jaharlal Ganguli of Vill- Ladhurka, PS - Hura, Dist - Purulia along with seized one motorcycle (Honda Livo) having registration No WB56N-2888, I beg to report that today I SI Gopal Bhattacharyya along with C/1370 Satyendranath Prasad Singh and C/2886 Arup Gorai all of Hura PS were performing mobile duty vide Hura PS C.C No - 436/22 dtd. 16.02.2022 and while we reached at Ladhurka Traffic More under Hura PS area at about 13:05 hrs, We found One Honda Livo Motor Cycle was going from Ladhurka side towards Kashipur side with rash and negligently. We tried to stop him but the rider of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such riding. After a hot chase we could be able to stop him at Ladhurka near Ladhurka High School under Hura PS, Purulia. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. On demand he also failed to produce any driving license. It is known from online searching that he is the registered owner of the said motorcycle.

Accordingly, I seized the motor cycle having registration No- WB56N-2888, Engine No - JC71ET3006263 & Chassis No - ME4JC717BJT004069 (Honda Livo) with a view to prosecute him U/S 279 IPC and 181/184 MV Act 1988. The whole process of seizure was completed in between 13:10 hrs and 13:35 hrs. I also arrested him at 13:45 hrs. as he violated sec 279 IPC and 181/184 MV Act 1988 in presence of police party. His family member was also informed over cell phone about the ground of arrest. I had to take him custody and to arrest him as because local people may assault him for his offence & L/O situation may be broken by local people and also with a view to prevent the accused from committing any further offence as it is learnt from local witnesses that he has the tendency of taking the law in his own hand and very much revengeful in nature and his local reputation is very bad.

Hence I pray that a specific case U/S 279 IPC and 181/184 MV Act 1988 may kindly be initiated against accused Susanta Ganguli (26 yrs.) S/O Jaharlal Ganguli of Vill- Ladhurka, PS - Hura, Dist - Purulia and arrange its investigation.
