Sir,

In producing herewith one arrested accused person namely Atul Mahato (42) S/o Late Nirmal Mahato of Vill Buribir, Tulin, PS Jhalda, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. 20 (Twenty) pieces of plastic bottles Country Sprit having 600 ML in each bottles printed as "Dil Khush" out of which one bottle of 600 ML taken as sample under proper seizure with label.

I SI Milan Manna of Tulin OP under Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that on 01/02/2022 myself aonghwith C/365 Bikram Roy, JC/1452 Yudhistir Kumar were performing Spl. Raid duty at PS area vide Tulin OP CC No. 187/22 dtd 01.02.22 and received a credible source information that one person is selling ID liquor illegally at his Pan stall at Buribir village under Jhalda PS. Myself alongwith force left for Buribir village to workout the information. At 17:15 hrs reached at the said Pan stall at Buribir village under Jhalda PS and found that the above noted accused person was selling country sprit illegally. On seeing police he conceal his presence at that shop but on search we able to trace out him and also found 20 (Twenty) pieces of plastic bottles Country Sprit having 600 ML in each bottles printed as "Dil Khush" which was kept conceal in his shop. On being asked he disclosed his identity as noted above. On interrogation, he stated that he was selling illicit country sprite liquor to local people on that area. On demand he failed to produce any valid documents in respect of selling such illicit country liquor. So, it is reasonable to believe that he was selling ID liquor illegally without any valid license. So, I seized 20 (Twenty) pieces of plastic bottles Country Sprit having 600 ML in each bottles printed as "Dil Khush" out of which one bottle of 600 ML taken as sample in between 17:45 hrs to 18:05 hrs after preparing proper seizure list duly sign by witnesses and label it and I arrested said accused person namely Atul Mahato (42) S/o Late Nirmal Mahato of Vill Buribir, Tulin, PS Jhalda, Dist.- Purulia at 18:15 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Atul Mahato (42) S/o Late Nirmal Mahato of Vill Buribir, Tulin, PS Jhalda, Dist.- Purulia u/s-46A (c) of the Bengal Excise Act 1909.


