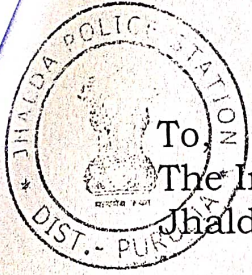

Sir,

In producing here with arrested accused persons namely 1) Krishna Bauri @ Chalak (27 yrs) S/O-Sukram Bauri @ Chalak of Jhalda Kumar Kuli, Ward No-06, PS-Jhalda, Dist-Purulia, 2) Riyasat Kaji @ Raja (28 yrs) S/O-Kalam Kaji of Vill-Hussaindih, PS-Jhalda, Dist-Purulia 3) Samiulla Khan @ Kismat (49 Yrs) S/O Lt. Azad Khan of Vill-Hussaindih, PS-Jhalda, Dist- Purulia 4) Sujit Paramanik (28 yrs) S/O Harekrishna Paramanik of Vill-Bansha, PS- Jhalda, Dist- Purulia and seized articles (1) One Tabla (Tangi) attached with bamboo handle length approx 3.5 ft and the sharp edge of Tangi is approx 6 inches (2) One small sword made of iron attached with wooden handle length approx 2 ft (3) one sword made of iron with iron handle length approx 4 ft (4) one iron pipe length approx 3 ft (5) one nylon rope in yellow colour length approx 20 mtr (6) one bamboo stick length approx 4.5 ft (7) one bamboo stick length approx 3 ft lodged complain against them and 12 others, Sk Soleman , Murselim, Hati, Nijam all of Jhalda were among them to the effect that on 18.02.2022 at about 00.25 Hrs during my night mobile duty received a credible tip that a gang of dacoits being armed with deadly weapons assembled under a Palash tree in a patch of Jungle situated near the Kanhwa Bandh under Gokulnagar Mouza and they were preparing themselves for committing dacoity at Jhalda Town. Subsequently I, informed to you as well as the Duty Officer and as per your direction I asked the duty officer to note the information down in the GDE Vide Jhalda PS GDE No 682 Dated 18.02.2022. On getting the tip off as per kind order myself accompanied with force who were detailed for the Night Mobile Duty with me namely C/-1284 Pratapaditya Majhi, C/-2182 Md. Safiul Khan, NVF/843 Bibekananda Mahato , HG/1772 Fatik Ch Kumar all of Jhalda PS vide CC No. 449 dated 17.02.2022 & vide Jhalda PS GDE NO 678 Dated 17.02.2022 immediately proceeded to the anticipated place of assembly to work out the information and reached near Gokulnagar more at 00:55 Hrs leaving the Police vehicle No- JH 09V 6985 and started to proceed for the anticipated place on foot. At 01:05 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 15/16 persons assembled under a Palash tree in a patch of Jungle situated near the Kanhwa Bandh 40 mtr away from the Jhalda-Bagmundi main Road and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up only 04 (Four) of them at 01:15 Hrs while the rest 11/12 had managed to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to search them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered the following articles from the exclusive possession of the respective accused person 1) One Tabla (Tangi) attached with bamboo handle length approx 3.5 ft and the sharp edge of Tangi is approx 6 inches from the possession of Krishna Bauri @ Chalak, 2) One small sword made of iron attached with wooden handle length approx 2 ft from the possession of Riyasat Kaji @ Raja, 3) one sword made of iron with iron handle length approx 4 ft from the



possession of Samiulla Khan @ Kismat, 4) one iron pipe length approx 3 ft from the possession of Sujit Paramanik, 5) one nylon rope in yellow colour length approx 20 mtr from the possession of Krishna Bauri @ Chalak and rest incriminating articles were found at the PO. Subsequently, I seized in between 01:35 hrs to 02:25 hrs on 18.02.22 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities, (1) One Tabla (Tangi) attached with bamboo handle length approx 3.5 ft and the sharp edge of Tangi is approx 6 inches (2) One small sword made of iron attached with wooden handle length approx 2 ft (3) one sword made of iron with iron handle length approx 4 ft (4) one iron pipe length approx 3 ft (5) one nylon rope in yellow colour length approx 20 mtr (6) one bamboo stick length approx 4.5 ft (7) one bamboo stick length approx 3 ft from the place of assembly under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat. On interrogation they confessed their guilt and they stated that they have assembled there with 12 others, Sk Soleman , Murselim, Hati, Nijam all of Jhalda were among them for committing a house dacoity in a Maru family at Jhalda Town .I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place, so I could not able to accompany with public witness. Under such circumstances it is reasonable to believe that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those persons after preparing memo of arrest and ground of arrest duly communicated to them.


Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Krishna Bauri @ Chalak (27 yrs) S/O-Sukram Bauri @ Chalak of Jhalda Kumar Kuli, Ward No-06, PS-Jhalda, Dist-Purulia, 2) Riyasat Kaji @ Raja (28 yrs) S/O-Kalam Kaji of Vill-Hussaindih, PS-Jhalda, Dist-Purulia 3) Samiulla Khan @ Kismat (49 Yrs) S/O Lt. Azad Khan of Vill-Hussaindih, PS- Jhalda, Dist- Purulia 4) Sujit Paramanik (28 yrs) S/O Harekrishna Paramanik of Vill- Bansha, PS- Jhalda, Dist- Purulia along with 12 others, Sk Soleman , Murselim, Hati, Nijam all of Jhalda were among them and others under proper section of law.
