Sir,

In producing herewith one arrested accused person namely I. Tarani Lohar (45) S/O Sukuya Lohar of Vill.- Hensla, PO-Karmadih, PS-Jhalda, Dist.- Purulia under arrest along with seized articles as per seizer list i.e. (i) 06 (six) Ltrs. ID Liquor (Cholai) in a Plastic Jarican (ii) 20 pieces of plastic glass under proper seizure with label.

I SI Asoke Kr. Sen of Jhalda PS hereby lodged a written complaint against the above noted accused person to the effect that today (18/02/2022) myself along with C/04-Abadut Kumar, C/214-Sidhartha Mandal, NVF/39-Lalit Kishor Mahato, NVF/778-Samir Ch. Mahato all of Jhalda PS were performing anti crime special mobile duty (This refers to Jhalda PS CC No. 460/22 dated 18/02/2022 and GDE No. 721 dated 18/02/2022. During special mobile duty at about 18:25 hrs I received a credible source information that the above noted accused person was selling ID Liquor (Cholai) illegally at Hensla village in his house under this PS. On receipt such information I immediately informed the matter to IC of the PS and as per his direction I along with force proceeded to work out the information. At 19:05 hrs we reached at Hensla village and my source shown the person from a distance who was selling the liquors there. We immediately reached there and surrounded them, but other people who were assembled there to purchase liquor, on seeing Police Party managed to flee away from the spot. On searched (i) 06 (six) Ltrs. ID Liquor (Cholai) in a Plastic Jarican and (ii) 20 pieces of plastic glass were found there. On demand he failed to produce any license / authority of the said liquors. On interrogation he also made incoherent statement regarding possession of said liquors and told that he is usually selling the same to the villagers illegally. So, finding no any other alternative I seized the above noted articles from the possession of the accused person and labeled, duly signed by the accused person & witnesses in between 19:35 hrs to 19:55 hrs in which 500 ML of ID Liquor (Cholai) in a bottle from mother sample were kept as sample with label. During interrogation he confessed his guilt as such I arrested him at 20:00 hrs after observing all the formalities as per law issuing memo of arrest as the accused person is liable for prosecution U/S-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused person namely Tarani Lohar (45) S/O Sukuya Lohar of Vill.- Hensla, PO-Karmadih, PS-Jhalda, Dist.- Purulia U/S-46A (c) of the Bengal Excise Act 1909.
