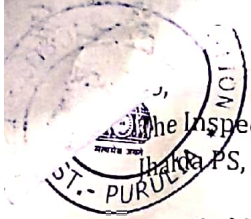

Sir,

In producing here with 01(One) arrested accused person namely Dilip Mahato (32) S/O Harendranath Mahato of Vill- Karadih, PO-Ichag, PS- Jhalda, Dist- Purulia and along with 01(one) seized Tractor having registration no- WB55A 1930 is attached with sand loaded trolley (approx 100 cft). The fact in brief is that today (20.02.2022) I along with force namely i) C/1207-Tarit Kr. Majhi ii) C/1484-Kajal Kr. Nayak iii) NVF/1036-Parmatha Kuiry was performing evening mobile duty in PS area vide Jhalda P.S. GDE No- 806 Dated- 20/02/2022 in consonance with Jhalda PS CC No- 478/22 Dated- 20/02/2022. During my evening mobile duty I received credible source information that one Tractor was lifting & carrying sand illegally and coming from Shyamnagar ghat towards Jhalda Town. Subsequently, I informed you and as per your gracious order, I placed Naka at Kutidih more to work out this tip off and started Naka Checking after proper placing guard rail on the road. Thereafter I saw the one Tractor was proceeding towards Kutidih more. Consequently, we intercepted the said Tractor at before Naka checking point at about 17:15 hrs and found that the vehicle as well as goods as identical as I received prior information. But seeing the Police Party driver who was on that vehicle (Tractor) started to flee away. After hot chase we managed to apprehend him. On asking he stated his name and address is Dilip Mahato (32) S/O Harendranath Mahato of Vill- Karadih, PO-Ichag, PS- Jhalda, Dist- Purulia and on interrogation he also confessed that he is the driver cum owner of the said tractor having registration no- WB55A 1930. On demand, he failed to produce any papers in respect of the said Tractor which is attached with Trolley as well as loaded sand though sufficient time was given. During interrogation, the he confessed that he had been running a clandestine business of sand by illegal means for selling the same to make profit dishonestly. So it is reasoned to belief that he in cahoots procured the said sand from Shyamnagar Ghat of Subarnarekha River by fraudulently means or theft by any means for transporting the same to run clandestine business. Ergo I, seized the vehicle 01 (one) tractor having registration No- WB55A 1930 is attached with sand loaded trolley (approx 100 cft) under proper seizure list in presence of available witnesses duly signed by them and arrested him under proper arrest memo and informed him the ground of arrest. Thereafter, I brought the said tractor to Jhalda PS compound.

Under the above facts and circumstances kindly take lawful action against the Owner cum driver of the said vehicles as he committed an offence U/S 379/411/414/120B of the IPC & 21 (4) Mines and Minerals (R&D) Act-1957.
