Sir,

In producing here with me arrested accused person namely Santu Bagti @ Sanju (31) S/O Sitaram Bagti of Bagtipara, Ward No-10, PS-Jhalda, Dist-Purulia under proper seizure of (i) 18 (Eighteen) sealed bottles of Codeine Phosphate & chlorpheniramine maleate known as ESkuf cough syrup of 100 ml each @ Rs 175/- stuffed into a green /white lylon bag after preparing proper seizure list duly sign by the witnesses.

I, SI, Prasanta Sau of Jhalda PS do here by lodged a written complaint against Santu Bagti @ Sanju (31) S/O Sitaram Bagti of Bagtipara, Ward No-10, PS-Jhalda, Dist-Purulia to the effect that today [11/02/2022] at 15:45 hrs. while performing evening mobile duty (This refers to Jhalda PS GDE No. 393 Dt. 11/02/2022, vide C.C. No. 397 Dt. 11/02/2022) received a tip off that illegal cough syrup are stored in the residential house of Santu Bagti @ Sanju at Bagti Para under Jhalda P.S. I communicated the matter to you over telephone and noted the fact in GDE vide Jhalda PS GDE No 409 dated 11/02/2022 and as per your order I, along with C/1284 Pratapaditya Majhi, C/1496, Subal Ch. Mahato, NWP/039 Lalit Kishor Mahato, HG/1807 Shyam Sing Laya of Jhalda P.S proceeded to work out the information. We reached at Bagti Para at 22:00 hrs and parked the Govt. vehicle in a safe distance and conducted raid in the house of Santu Bagti @ Sanju (31) S/O Sitaram Bagti of Bagtipara, Ward No-10, PS-Jhalda, Dist-Purulia at 22:05 hrs. I along with force searched the house thoroughly and found illegal cough syrup stuffed into a green/white colour lylon bag which was covered up with other household articles at the floor of the rooftop. I asked him to produce any valid license in respect of keeping said illegal drugs. But he failed to produce any valid documents in respect of said drugs. So, I seized (i) 18 (Eighteen) sealed bottles of Codeine Phosphate & chlorpheniramine maleate known as ESkuf cough syrup of 100 ml each @ Rs 175/- stuffed into a green /white lylon bag from the possession of Santu Bagti @ Sanju in between 22:15 hrs to 22:55 hrs after preparing proper seizure list duly sign by the available witnesses and labelled it from which 01 (one) bottle of cough syrup was kept at sample. I searched for the public witness but due to the severe cold night none stood as witness before me. On interrogation, he confessed his guilt and admitted that he with the help of Bokta Itajak of Jargo and others gathered the illegal cough syrup for the purpose of sale. Subsequently, at 23:05 hrs I arrested Santu Bagti @ Sanju (31) S/O Sitaram Bagti of Bagtipara, Ward No-10, PS-Jhalda, Dist-Purulia for violation of Sec-27 of Drugs & Cosmetics Act-1940 and after maintaining all the formalities regarding arrest and all the guide line of Hon'ble Supreme Court and NHRC.

I, therefore pray before you to start a specific case against accused person named Santu Bagti @ Sanju (31) S/O Sitaram Bagti of Bagtipara, Ward No-10, PS-Jhalda, Dist-Purulia as per law and arrange for its investigation.
