
In producing here with 03 accused persons namely (1) Sushen Kr Nayak (29 yrs) S/o-Baidyanath Nayak of Vill-Brajopur PS-Jhalda Dist-Purulia (WB) (Driver of vehicle No-PB13AF-6825) (2) Harikishor Singh (60 yrs) S/o-Late Ganapat Singh of Vill-Kachua Sali PS-Palpur Dist-Deoghar State-Jharkhand (Driver of vehicle No- CG04JA-9526) (3) Md Kadir (30 yrs) S/o-Md. Hanif of Vill-Bastar PS-Sarath Dist-Deoghar State-Jharkhand (Driver of vehicle No- JH02AV-9007) along with seized articles; i.e. 12 (Twelve) vehicles having Registration Nos (1) JH02W-5944 loaded with approx 05 TN coal (2) JH02AC-4195 loaded with approx 05 TN coal (3) WB23D-3426 loaded with approx 23 TN coal (4) JH10T-9869 loaded with approx 05 TN coal (5) CG04JA-9526 loaded with approx 18 TN coal (6) PB13AF-6825 loaded with approx 22 TN coal (7) JH09AA-0291 loaded with approx 22 TN coal (8) JH10CH-9135 loaded with approx 02 TN coal (9) JH02AV-9007 loaded with approx 03 TN coal (10) WB55A-7707 loaded with approx 02 TN coal (11) JH02AW-7659 loaded with approx 02 TN coal (12) JH02T-8662 loaded with approx 06 TN coal, seems to be steam coal and also taken sample of 05 kg from each truck to the effect that I along with C/-1521 Papu Ghimar C/-2238 Ratan Shit JC/-1035 Mrinmay Khiladi C/-2976 Rabi Dutta C/-1190 Swapan Gorain R/M-1530 Biky Magar all of Baglata IC under Joypur P.S were engaged in mobile duty vide Baglata IC P.S CC No 310/22 Dated 18.02.22 at about 19.35 hrs in course of mobile duty received a credible source information that huge quantity of illegal coal is stocked at Karkara village under this PS area, in the coal procurement and storing point of Amit Singh @ Amit Raj Chowdhury. After receiving information contacted with my I/C and informed the matter and as per kind order myself accompanied with force immediately proceeded to said coal procurement and storing point of Amit Singh @ Amit Raj Chowdhury to work out the information. We reached on the said coal procurement and storing point at about 20.25 hrs, on seeing the police party 15/20 persons were fled away from the side of coal procurement and storing point. But somehow we are managed to apprehend the above noted persons. On asked they failed to produce any valid documents in respect of loaded coal. Accordingly, I arrested them after observing all formalities regarding arrest and seized the above noted vehicles loaded with coal under proper seizure list. On carefully searched near by the vehicles I found (1) 15 nos of "Belcha" and 25 nos of "Dhama" and (2) 01 Electronics weighing machine and accordingly I also seized the same under proper seizure list duly signed by the accompanied police person as there was no availability of any local person, as such I could not collect the signature of the local people in all seizure list.


On preliminary enquiry it could be learnt that said coal procurement and storing point owner namely Amit Singh @ Amit Raj Chowdhury and his associates were procured the said illegal coal from different places and transporting the same in a clandestine manner to another district/state. He is habitually dealing this business since long time.

So, it is reasonable to believe that the coal procurement and storing point owner namely Amit Singh @ Amit Raj Chowdhury and his other associates have obtained the said coal and stocked illegally either by theft or by any fraudulent means and trying to dispose the same coal in a clandestine manner to another district/state. Accordingly made proper arrangement and brought the seized coal at PS to keep at PS compound.

Therefore, I pray that a specific case may kindly be registered against Amit Singh @ Amit Raj Chowdhury S/o-Radheshyam Chowdhury of Majhi tola Narkera PS-Balidih Dist-Bokaro (JH) along with above noted three arrested persons, driver and owner of the 12 (twelve) seized vehicles and other associates under proper section of law.
