In producing here with one seized vehicle having Registration No- JH02AN-4772 (Truck) loaded with approx 22 TN coal seems to be steam coal and also taken sample of 05 kg from the truck, to the effect that I along with C/-2219 Tonmoy Saha, C/-2937 Subrata SM Patra, C/-2996 Prasanta Roy, C/-2849 Asim SM Patra JC/-1336 Sagir Ansary, R/M-7348 Awesn Thapa, R/M-Bikky Mukhiya all of Baglata IC under Joypur I'.S were engaged in Night & Simultaneous drive mobile duty at PS area vide Baglata IC under Joypur P.S CC No- 311/22 Dated 18.02.22 at about 22.05 hrs in course of mobile duty received a credible source information that huge quantity of illegal coal is stocked at Damru village under this PS area, in the coal procurement and storing point of Amit Singh @ Amit Raj Chowdhury. After receiving information contacted with my I/C and informed the matter and as per kind order myself accompanied with force immediately proceeded to said coal procurement and storing point of Amit Singh @ Amit Raj Chowdhury at Kashipur village, to work out the information. We reached on the said coal procurement and storing point at about 23.15 hrs, on seeing the police party 2/3 persons were fled away from the side of coal procurement and storing point. Accordingly, I seized the above noted vehicle loaded with coal dust under proper seizure list duly signed by the accompanied police persons as there was no availability of any local person, as such I could not collect the signature of the local people in all seizure list.

On preliminary enquiry it could be learnt that said coal procurement and storing point owner namely Amit Singh @ Amit Raj Chowdhury S/o-Radheshyam Chowdhury of Majhi tola Narkera PS-Balidih Dist-Bokaro (JH) and his associates were procured the said illegal coal from different places and transporting the same in a clandestine manner to another district/state. He is habitually dealing this business since long time.

So, it is reasonable to believe that the procurement and storing point owner namely Amit Singh @ Amit Raj Chowdhury and his other associates have obtained the said coal and stocked illegally either by theft or by any fraudulent means and trying to dispose the same coal in a clandestine manner to another district/state. Accordingly made proper arrangement and brought the seized coal at PS to keep at PS compound.

Therefore, I pray that a specific case may kindly be registered against Amit Singh @ Amit Raj Chowdhury S/o-Radheshyam Chowdhury of Majhi tola Narkera PS-Balidih Dist-Bokaro (JH) along with the driver and owner of the Truck JH02AN-4772 (Truck) seized vehicles and other associates under proper section of law.
