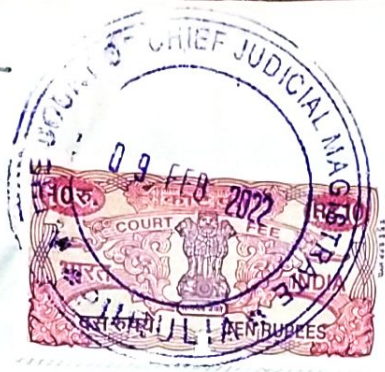

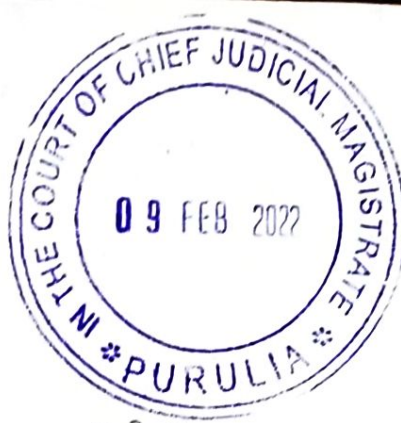

Most respectfully begs to state:-

1. That your petitioner/complainant is permanent resident of Vill. Ropo, P.S. Joypur, Dist. Purulia and within the jurisdiction of this court.
2. That on 28.9.2021 all the accused persons suddenly entered in the land being R.S. Plot No. 3644 area 1 acre 22 decs. of mouza Ropo of your complainant taking with deadly weapons like tangi, lathi, kural and cut down several bamboo trees and

in presence of complainant and witness . All the accused persons forcibly took away all trees to their house.

3. That your complainant and witnesses raised objection and protested but they attack them with deadly weapons with illegal motive and sought that they will kill them any how they manage to escape. That the value of the said trees is more than Rs.10,000/-(Rupees ten thousand).

5. That the matter has been reported to the O/C Joypur P.S. on ^{sv}28/9/21 but no action has been taken thereafter the matter was informed to the S.P.Purulia but no good.

It is therefore prayed that your Honour be pleased to send this complaint petition to the O/C Joypur P.S. for investigation after treating same as F.I.R. in u/s.156(3) Cr.P.C. for the ends of justice.
