

The above named complainant begs to state as follows:-

Most respectfully sheweth: -

- That, complainant happens to be a local resident of Vill.-Chowkibera, P.O.- Chowkibera, P.S. Joypur, Dist. Purulia, PIN: 723215 (W.B.).
- That your petitioner and his family members belong to "SANTAL" by cast.
- That the accused namely Tulsi Mahato S/o Lalu Mahato about two months abusing the petitioner and his family members with filthy languages and he also have been abusing his cast.
- 4. That Tulsi Mahato also abused complainant and his caste by saying "CHOTO JHAT" (ছোট জাত).
- That the accused person Tulsi Mahato also said languages many times that as petitioners are of low cast for this



reason petitioner and his family members will not take bath or use water from the village pond "Mahato Bandh".

- 6. That on 24/11/2021 at about 11 a.m. morning the petitioner and his brother namely Debu Mandi and his wife namely Parbati Mandi are working Infront of his own house, at that time accused Tulsi Mahato came that place and started to abuse them as low cast (Choto Jhat) and threatened them that if we don't leave this village, he will kill each and every one of petitioners family.
- 7. That thereafter the complainant reported a written complaint in the said incident before the local Police station by registered post on 29/11/21 but police did not any legal action against the accused person.
- 8. That after finding no other alternative your petitioner has knocked the door of the superintendent of police Purulia on 06/12/21, but nothing has been done by the said authority.
- That, proper police investigation should be taken up by treating this complaint as F.I.R. and action should be taken



against the accused person as per law for the Interest of Justice.

- 10.That, as Joypur Police Station on Specific information of the complaint have not instituted any F.I.R. let this complaint be forwarded to joypur police station for treating the same as F.I.R. and for under taking investigation.
- 11. That the accused person is continuously threatening the complainant and his family members of further dire consequence, and petitioners family members leaving in fear.

Hence it is prayed that your Honour will graciously be pleased to pass appropriate orders U/S-156(3) Cr.P.C. or to treat this Petition/Complaint as F.I.R. and undertake proper Investigation.
