Respected Sir,

In producing herewith 01 (one) arrested accused person namely Ajit Mahato (34 yrs) S/o-Baidyanath Mahato of Vill-Hetkahan, PS-Joypur, Dist-Purulia along with seized Mahendra Yoba Tractor having Regd. No-WB55B-4014 loaded with sand (100 CFT approx) under proper seizure list, I beg to submit that today (24/02/2022) I PLSI Sumana Kar along with (1) R/M 7320 Durjan Ch. Rava (2) R/M 7471 Parash Biswakarma both of Joypur P.S were performing Special Mobile duty vide Joypur PS CC No-624 Date-24/02/2022. During my mobile duty at about 15:45 hrs received a credible source information that one tractor loaded with sand is coming from Hetkahan side, I along with force reached at Dhanukdih more under Joypur PS and found that a Tractor having Regd. No-WB55B-4014 loaded with sand was coming from Hetkahan village side. On seeing the Police party at Dhanukdih more, the driver of the said Tractor were trying to fled away. But after a hot chase, we could able to detain the driver of said tractor having Regd. No-WB55B-4014. On integration he made incoherent statement at different time. He disclosed his identity as Ajit Mahato. I asked the driver Ajit Mahato to produce valid documents in respect of said sand but he failed to produce any documents regarding lifting & transportation of sand. I interrogated him thoroughly. During interrogation, he admit that he is dealing with illegal sand lifting from Kangsabati riverbed and transporting the sand. The driver also failed to produce any paper in respect of the Tractor. Hence, I seized the one Mahendra Yoba Tractor having Regd. No-WB55B-4014 loaded with sand (100 CFT approx) in between 16:25 hrs to 16:35 hrs under proper seizure list in presence of available witnesses duly signed by them and I arrested Ajit Mahato (34 yrs) S/o-Baidyanath Mahato of Vill-Hetkahan, PS-Joypur, Dist-Purulia. After observing all formalities & disclosed him about the ground of arrest. I brought the said Tractor to Joypur P.S. As such there is every reason to believe that the driver of the said Tractor is dealing with sand illegally and transporting with ill motive without any valid document.

So he is liable for offence punishable U/S- 379/411/414 IPC & 21 (1) (4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against Ajit Mahato (34 yrs) S/o-Baidyanath Mahato of Vill-Hetkahan, PS-Joypur, Dist-Purulia may kindly be started and arrange for its investigation.
