Sir

In producing herewith an arrested accused person namely **Santosh Singh(34), S/O- Lt Lalan Singh of H-184, New Colony, Kurmidhi, PO- Railway Colony, PS-Balidih, Dist-Bokaro, Jharkhand**, with seized articles as an improvised country made pistol with Magazine loaded three round live ammunition and one motor bike, in proper seizure list duly signed by the witnesses. I, ASI Dhritiman Rakshit of Baglata Investigation Centre under Joypur PS do hereby lodge complaint that today (14.02.2022) at about 19:25 hrs, during my evening mobile duty, when myself along with force C/1190 Swapan Gorain & C/120 Sandip Kumar was performing NAKA checking at Jala Border (interstate Naka Point) under Joypur PS (Vide Baglata IC CC No-279/22, Dated-14.02.22 & GDE No-387, Dated-14.02.22), at that time we saw one motor bike is coming from Jharkhand side, police party stopped the said motor bike and found it was one blue colour 'Royal Enfield Bullet having Reg No-JH-05U-0166' with one rider. I asked the said rider of motor bike to show his valid document of the bike but he unable to produce any valid document of his motor cycle. Accordingly I asked his name and identity, but he gave in-coherent statements and tried to flee away which was very suspicious. Then, I detained him, and I searched him maintaining all formalities, and found an improvised country made pistol, with Magazine loaded three round live ammunition which was inserted into the pant on the left side of the back of his waist. I asked him to produce valid license in respect of said fire arms but he failed to produce any valid documents in respect of possessing of said fire arms and ammunition. On interrogation he disclosed his name and identity as noted above. So, I seized said improvised country made pistol, with Magazine loaded 03 round 7.63 mm live ammunition and said motor bike in between 20.05 hrs & 20:50 hrs after preparing proper seizure list duly signed by the witnesses. I also arrested the above noted accused person in 21:05 hrs after maintaining all the formalities regarding arrest as he illegally possessed fire arms and live ammunition to use those for unlawful purpose.

Seized articles are:

1. One improvised country made pistol (marked on it, as 'made in USA') with Magazine loaded (length of the fire arms approx 16 cm, length of butt approx 08 cm, length of magazine approx 10 cm).
2. Three (03) 7.63mm live ammunition (made with metal like brass & copper) which was fitted into the magazine of the pistol (noted in article no-01).
3. One blue colour motor bike 'Royal Enfield Bullet' having Reg No-JH-05U-0166.

I also tried to collect the public witnesses but the place was lonely and nobody was available there to sign on the seizure list as public witness. After return to P.S, I produce the arrested accused along with seized fire arms and live ammunition to start a specific case as per law.

Under above circumstances, I, therefore, pray that a case U/S 25(1)(a) of Arms Act may kindly be initiated against accused Santosh Singh(34), S/O- Lt Lalan Singh of H-184, New Colony, Kurmidhi, PO- Railway Colony, PS-Balidih, Dist- Bokaro, Jharkhand.
