Respected Sir,

In producing herewith arrested accused Kebal Garai (48 Years) S/O Madan Garai of village - Sutabai, PS - Kashipur, Dist - Purulia along with seized articles, I beg to report that on 01.02.2022 at 16.45 hrs during my mobile duty received telephonic information that the above noted accd selling liquor at Sutabai village in his house. Accordingly I, SI Kalyan Kr Sakha along with C/793 Prasanta Kr Patra and C/797 Chandi Charan Rajak reached at Sutabai village in his house of the above noted accused at 17.25 hrs and found that one person was selling Liquor in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document for selling liquor in his possession. So the above noted accused has committed an offence u/s -46(A)(c) B.E. Act 1909 Amended up-to date. During search I found One white colour plastic jarikin loaded with approx 10 (Ten) liters ID liquor (Chullu) out of seized ID liquor 300 ml taken out in a bottle as sample with sealed and labeled.
