

Sir,

In producing here with 03 accd persons namely (1) Akhilesh Ray (32 years) S/O Bhagwan Ray of Fatchpur, PO - Brit Bhagwanpur, PS - Panapur, Dist - Saran, Bihar (2) Jaynath Prasad Yadav (32 years) S/O Fagu Ray of Fatehapur, PO - Brit Bhagwanpur, PS - Panapur, Dist - Saran, Bihar and (3) Jai Ram Yadav (45 Years) S/O Budhu Yadav of Dayaldih, PO - Chandrashaili, PS - Khaira, Dist -Jamui, Bihar along with seized articles i.e. 06 (Six) vehicles having registration Nos (1) WB 15C/4554 loaded with approx 25 TN coal & Dust mixed (2) WB 37D/7000 loaded with approx 25 TN coal (3) WB 37C/8662 loaded with approx 25 TN coal (4) WB 37D/8922 loaded with approx 20 TN coal (5) WB 37D/7260 loaded with approx 30 TN coal and (6) WB 55A/3923 loaded with approx 10 TN dust coal, seems to be steam coal and also taken sample of 05 kg from each truck to the effect that I along with C/2280 Akinchan Mandal, C/2180 Rajkumar Chalak both of Kashipur P.S were engaged in mobile duty vide Kashipur P.S CC No 339/22 Dtd 02.02.22 at about 21:35 Hrs in course of mobile duty received a credible source information that huge quantity of illegal coal is stocked at under Saldiha Mouja at Babirdih Village, in the brick kiln style as MGC of Srikanta Dey S/O Nandalal Dey of village Gourangdih, PS Kashipur, Dist - Purulia. After receiving information contacted with my O/C and informed the matter and as per kind order myself accompanied with force immediately proceeded to said brick kiln to work out the information. We reached on the said brick kiln at about 22.15 hrs, on seeing the police party 07/08 persons were fled away from the side of brick kiln. But somehow we are managed to apprehend the above noted persons. On asked they failed to produce any valid documents in respect of loaded coal. Accordingly, I arrested them after observing all formalities regarding arrest and seized the above noted vehicles loaded with coal under proper seizure list. On carefully searched near by the vehicles I found (1) 07 nos of "Belcha" and 15 nos of "Dhama" and also found (1) Orpat calculator 02 pieces (2) 01 Electronics weighing machine and (3) 01 Exercise book of settle accounts from a shed situated in said brick kiln, accordingly I also seized the same under proper seizure list duly signed by the accompanied police person as there was no availability of any local person, as such I could not collect the signature of the local people in all seizure list.

On preliminary enquiry it could be learnt that said brick kiln owner namely Srikanta Dey and his associates were procured the said illegal coal from different places and transporting the same in a clandestine manner to another district/state.

So, it is reasonable to believe that the brick kiln owner nan ally Srikanta Dey and his other associates have obtained the said coal and stocked illegally either by theft or by any fraudulent means and trying to dispose the same coal in a clandestine manner to another district/state. Accordingly made proper arrangement and brought the seized coal at PS to keep at PS compound.

Therefore, I pray that a specific case may kindly be registered against Srikanta Dey S/O Nandalal Dey of village Gourangdih, PS Kashipur, Dist – Purulia along with above noted three arrested persons, driver and owner of the 06 (Six) seized vehicles and other associates under proper section of law.
