Sub:- Prayer for lodge F.I.R
Sir,

With due respect I the under signed chief Inspector (F&S), Raghunathpur here by lodge a written complainat that today (22.02.2022) myself along with Inspector of Police, DEB, Purulia with his team held raid in the dealer shop (M.R dealer shop) of Dhruhalal Goswami of village Ghatrangamati, P.O- Ghatrangamati PS Kashipur Dist- Purulia after submission requisition before you vide Kashipur PS GDE No- 975 dtd- 22.02.2022 at 11.25 hrs. During holding raid I found one person who was running the M.R shop business . On being asked he stated that his name is Avijit Goswami @ Raju, he is son of Dhruhalal Goswami (owner of FPS & S.K.oil).He running the such business in favour of his father as his father is old aged person and now he is bed ridden condition. On demand the register of the shop he was submitted before me and which I was scrutinised the same and found some discrepancies of stock and sale of PDS Rice, Wheat, Atta, Sugar and S.K. Oil. During scrutiny of PDS commodities found that shortage of PDS Rice- 71(Seventy One) Bags i.e 35.5 Quintal, shortage of PDS Atta 26(Twenty Six) Bags i.e 12.35 Quintals, shortage of Wheat 30(Thirty) Bags i.e 15 (Fifteen) Quintals, shortage of Sugar 8(Eight) Kgs and excess of S.K.Oil 49 (Forty Nine) Ltrs. All stock are mentioned as per E-pose Machine slip and stock register. On demand he did not give ant satisfactory answer in supporting of such shortage of PDS items and excess of S.K.Oil. So, as per my direction Inspector DEB Purulia seized the following documents and register relating to PDS under proper seizure list duly signed by the Avijit Goswami @ Raju and available witnesses. 1)One stock summary report , report dated 22.02.2022, S/L No- 1 to 46 are mentioned on the slip of ration commodity , duly signed by Avijit Goswami on back side slip.2) one stock register which is certified by Inspector (F&S) on 02.03.21 containing page no 1 to 97. Dhruhalal Goswami , Ghatrangamati, 134002100056, Kashipur, Purulia are mentioned on the cover page of the register. 3) one S.K Oil stock register which is certified by Inspector (F&S) on 03.05.17, page no- 1 to 124 . OXFORD EXERCISE BOOK are mentioned on the cover page. 4) One hard copy of voucher issued from Prakash Sha, MR Distributor, Kashipur S/L no- 962 dtd- 21.01.22 in the name of Dhruhalal Goswami, Ghatrangamati.

5) One hard copy of voucher issued from Prakash Sha, MR Distributor, Kashipur in the name of Dhrubalal Goswami, Ghatrangamati S/L no 1036 dt- 27.01.22. 6) One hard copy of voucher issued from Prakash Sha, MR Distributor, Kashipur in the name of Dhrubalal Goswami, Ghatrangamati S/L No 1138 dt- 21.02.22. 7) One Road challan issued from Prakash Sha in the name of D.L Goswami , S/L No- 514 dt. 19.02.22. 8) One Road challan issued from Prakash Sha in the name of D.L Goswami , S/L No- 936 dt. 14.02.22 9) 49 (Forty Nine) Litres S.K Oil contained in a jarican. Above noted articles seized from the possession of Avijit Goswami failed to produced any valid documents in respect of shortage of PDS Rice, Atta, Wheat, Sugar and excess of S.K.oil. It is reason to believe that Avijit Goswami had sold excess PDS items in black market for his wrongful gain as well as deprived card holder beneficiaries. Hence, He violated provision led down in para- 7 on rule 3 of Govt. of West Bengal.

Thus Avijit Goswami S/O Dhrublal Goswami of village Ghatrangamati PS Kashipur Dist- Purulia committed an offence U/S 7(1)(a) (ii) of E.C(x) of Act 1955 accordingly.

The above noted seized articles S/L No- 1 to 8 handed over to Malkhana dealing Officer of Kashipur PS and S/L No- 9 left in zimma to one M.R dealer namely Bijoy Chandra Gorai S/O Narayan Chandra Gorai of Kashipur, Kolloli PS- Kashipur Dist- Purulia vide Licence No- 134002100019.

I, therefore requested to start a case U/S 7(1)(a) (ii) of E.C(x) of Act 1955 against accused person namely Avijit Goswami (38) S/O Dhrublal Goswami of village Ghatrangamati PS Kashipur Dist- Purulia.
