Sub: To lodge FIR against owners and drivers of (1) 01 (One) tractor i.e. Sonalika D1-35 Tractor having Engine No 3100FLU14A1013899F18 and Chassis No BZJSR1019012S3 (Without number plate) along with trolley (Without number plate) loaded with approx 45 CFT Sand.

Sir,

In producing herewith, (1) 01 (One) tractor i.e. Sonalika D1-35 Tractor having Engine No 3100FLU14A1013899F18 and Chassis No BZJSR1019012S3 (Without number plate) along with trolley (Without number plate) loaded with approx 45 CFT Sand (2) 02 pieces of Iron Made "Belcha" and (3) 02 Pieces of Iron made " Dhama".

The nub of the fact in a nutshell is that today on 22.02.2022 at 16.15 hrs. I SI Jagannath Saha of Kashipur PS along with (i) C/2169 Prasanta Lohar and (ii) C/117 Arpan Mandal both of Kashipur PS, Dist - Purulia, left the PS for performing evening mobile duty at Kashipur P.S area vide Kashipur P.S GDE No 992 Dtd - 22.02.2022 and C.C No. 547/22 Dtd. 22.02.2022. During my mobile duty, I received a tip off at 17.05 hrs. that some persons were loading a tractor with sand from the river bed of Darkeswar River near Shyambathan village under Kashipur P.S. Subsequently, I along with force moved to the spot. We kept the vehicle on the bank of river and proceeded towards the spot by foot. We came to find that few persons were loading sand in the attached trolley of said tractor. Seeing the Police party, those persons leaving the tractor (loaded with sand in the attached trolley) at Darkeswar River and fled away from the spot. We rushed to the Tractor and detained the said tractor. We searched the said tractor and found that the tractor is loaded with sand and also searched surrounding but could not trace out the persons & driver of said offending Tractor. I searched the vehicle if any valid documents is available regarding said loaded sand but found nothing. Hence, I seized the above noted tractor along with trolley loaded with sand and (2) 02 pieces of Iron Made "Belcha" (3) 02 Pieces of Iron made " Dhama" as noted above and brought the said seized articles to Kashipur PS. As there is every reason to believe that the driver and owner of the said tractor with ill motive were transporting sand illegally without any valid document in support of carrying sand.

Hence, I do hereby lodge this complaint against the owner and driver of above noted tractor along with the trolley for investigation.
