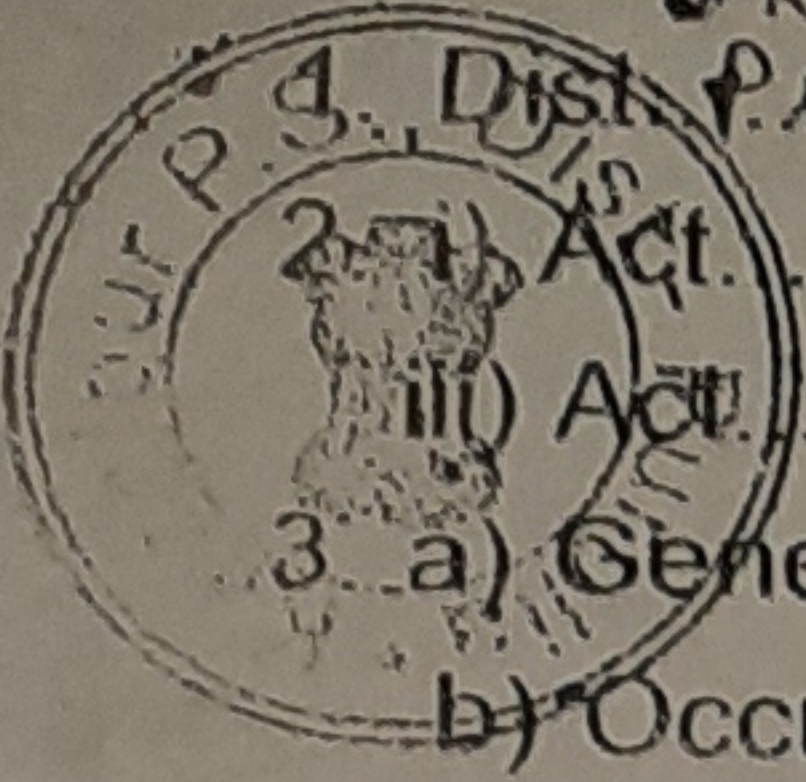

Respected Sir,

In producing herewith the 03(three) arrested accd. persons namely 1) Baban Bauri (30 yrs) s/o- Nripen Bauri of Shalroha, PS- Saltora, Dist- Bankura, 2) Shrimanta Bauri(47 yrs) s/o- Chandí Bauri of of Shalroha, PS- Saltora, Dist- Bankura, 3) Khokan Bauri (30 yrs) s/o- Sakit Bauri of Shalroha, PS- Saltora, Dist- Bankura along with seized stone approx. 30 cft and apparatus used by the miscreants for illegal mining and extraction of stone viz 1) 03 piece of "Gainti", 2) 02 piece of spade (Kodal) and 3) 01 piece Sabal made in Iron, 4) 06 pieces of iron Basket. I ASI Shibaram Bauri of Kashipur PS do here by lodge a complaint to effect that today on 11/02/22 I along with C/416 Sahadeb Hansda and NVF/041 Paltulal Mahato was engaged in day mobile duty at PS area vide Kashipur PS CC No- 426/22 dtd- 11.02.22 . In course of mobile duty at 09.45 hrs received reliable source information to the effect that illegal extraction work of stone is going on near Chuna village. Informed the matter to O/C Kashipur PS and as per your direction left for Chuna area to work out the information.

At about 10:35 hrs we reached near Chuna Village and started searching the area on foot by keeping our vehicle at a far distance for looking any activity of illegal mining and extraction of stone as the said area is known for illegal mining of stone. We proceeded towards Chuna Dungri and found some persons were engaged in extracting and mining stone by digging the earth. Some persons who were engaged in illegal extraction and mining were able to fled away on seeing us and getting the scent of police party, they started fleeing from the spot by taking the cover of the bushes. But with the efficiency of police party we able to apprehend three persons namely 1) Baban Bauri (30 yrs) s/o- Nripen Bauri of Shalroha, PS- Saltora, Dist- Bankura, 2) Shrimanta Bauri(47 yrs) s/o- Chandí Bauri of of Shalroha, PS- Saltora, Dist- Bankura, 3) Khokan Bauri (30 yrs) s/o- Sakit Bauri of Shalroha, PS- Saltora, Dist- Bankura. We also noticed that some apparatus used by the miscreants for illegal mining and extraction of quartz viz 1) 03 piece of "Gainti", 2) 02 piece of spade (Kodal) and 3) 01 piece Sabal made in Iron, 4) 06 pieces of iron made Basket was lying there . On being asked they failed to provide any satisfactory answer regarding their presence at that place and also failed to provide any valid documents. As such arrested them from that place after maintaining legal formalities. In between 12.05 hrs to 12.35 hrs I seized the said articles from spot under proper seizure list being duly signed by the accd. persons and available Police witnesses I also seized approx. 30 cft of Stone which was stored just near the extracting place in an open field under proper seizure list being duly signed by the witnesses. I also arranged for its dispatch to PS campus. Interrogated the arrested accd. persons and during interrogation they stated that they along with some others are dealing with stone illegally and in clandestine manner and use to sell stone by illegal way in connivance with others who are receiving this stolen stone for their wrongful gain by causing wrongful loss to the Govt. property. So they along with other unknown miscreants have committed offence which is punishable u/s 379/411/414/120 IPC and 21(1)(b) of Mines and Minerals Act.

After local enquiry the remaining culprits could be identified and necessary steps could be taken to nab them.

On return to Police Station I am submitting this complaint against three arrested accd. persons namely 1) Baban Bauri (30 yrs) s/o- Nripen Bauri of Shalroha, PS- Saltora, Dist- Bankura, 2) Shrimanta Bauri(47 yrs) s/o- Chandí Bauri of of Shalroha, PS- Saltora, Dist- Bankura, 3) Khokan Bauri (30 yrs) s/o- Sakit Bauri of Shalroha, PS- Saltora, Dist- Bankura and some unknown miscreants for committing offence as stated above and for starting a case against them under proper section of law.
