Respected Sir,

I, ASI Prasanta Sanyal of Kenda PS, Dist- Purulia producing herewith one arrested accused person namely Muklal Saren (50 yrs), S/o – Lt. Rupachand Saren of Vill- Sardardih-Mudidih, P.S – Kenda, Dist- Purulia with seized articles i.e. 1) one white colour jarican containing Approx 14 Ltrs. ID Liquor 2) 10 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from SI No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (01-02-2022) during special raid duty acting of a secret source information myself along with (1)C/-1345 Jitendranath Diasi, (2)NVF/129 Mahanta Murmu, (3)HG/-1923 Banamali Manki of Kenda PS conducted raid in the house of accused person Muklal Saren at about 18:05 hrs and found that he was keeping and selling of ID liquor at his residence to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized . 1) one white colour jarican containing Approx 14 Ltrs. ID Liquor 2) 10 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from SI No-01 & kept in a bottle which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Muklal Saren (50 yrs), S/o – Lt. Rupachand Saren of Vill- Sardardih- Mudidih, P.S – Kenda, Dist- Purulia as per proper section of law.
