In producing herewith one seized vehicle (Tractors) having Registration No. WB55B-5132, Engine No- E3585906, Chassis No. T053521128KK attached with Trolley without number plate loaded with sand approx. 100 cft. The fact of the case in brief is that on 27/02/2022 I along with C/195 Santosh Kr. Sing Sardar and C/1177 Samir Das of Kenda PS were on special raid duty. During raid duty on 27/02/2022 at about 18.55 hrs. when we reached near at Punura Morh found that the above noted tractor was coming from Lepodih side under Kenda PS. On seeing the Police party driver of the said tractor stopped his tractor in a distance and he fled away after keeping the tractor near at Punura Morh. We searched the said tractor and found that the tractor was loaded with sand.
