Respected Sir,

I, ASI Sukhendu Mandal of Kenda PS, Dist- Purulia producing herewith one arrested accused person namely Bhakta Ranjan Mahato (37 yrs), S/o – Lt. Banku Mahato of Vill- Balakdih, P.S – Kenda, Dist- Purulia with seized articles i.e. 1) one white colour jarican containing Approx 09 Ltrs. ID Liquor 2) 07 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from SI No-01 & kept in a bottle which were seized under proper seizure list.

I beg to submit that today (08-02-2022) during evening mobile duty acting of a secret source information myself along with (1) C/1130 Asik Ansari, (2) HG- 1933 Lakhiandar Mura both of Kenda PS conducted raid in the house of accused person Bhakta Ranjan Mahato at about 18:05 hrs and found that he was keeping and selling of ID liquor at his residence to the others. Seeing the Police party, all customers fled way but we managed to apprehended the accused person. On being asked he failed to produce any valid licence /documents in respect of storing and selling of ID liquor. As such I seized 1) one white colour jarican containing Approx 09 Ltrs. ID Liquor 2) 07 pcs plastic glasses (3) Approx 375 ml ID liquor as sample which was collected from seized articles from SI No-01 & kept in a bottle which were seized under proper seizure list in presence of witnesses and duly signed by them and also arrested the above noted person after informing him the ground of arrest and after observing all legal formalities. The seized articles were properly sealed and labelled in presence of witnesses. I also arranged to inform his family member about his arrest by police.

Under the above fact and circumstances, I therefore pray that a specific case may kindly be start against Bhakta Ranjan Mahato (37 yrs), S/o – Lt. Banku Mahato of Vill- Balakdih, P.S – Kenda, Dist- Purulia as per proper section of law.
