In producing herewith arrested accused person namely Rakesh Roy (19 Yrs) S/o- Brihaspati Roy of Vill- Deorang, PS- Kenda, Dist- Purulia along with one seized Honda Shine-SP, Black colour 125 CC Motor Cycle bearing Registration No-WB 56N-7593 and Eng. No- JC73E-T-2184541 & Chassis No- ME4JC737JJT098594.


I beg to report that today myself along with C/922-Sanjoy Bouri and NVF- 129 Mahanta Murmu both of Kenda PS were performing evening mobile duty at Kenda Jamtal Morh under Kenda PS area vide Kenda PS C.C No-208/22 dtd. 15.02.2022 and Kenda PS GDE No-490 dtd- 15.02.2022 at about 16:55 hrs, I found one motor Cycle bearing Registration No-WB 56N-7593 coming from Kenda village side rashly and negligently. We try to stop him but the driver of the said motorcycle named in above was trying to escape the place so rashly, there was every possibility of loss/ serious injury of nearby public due to his such driving. After a hot chase we could able to stop him. On being asked, he stated his name and address as noted above, but unable to give any satisfactory account for his such rush and negligent driving which may cause endanger to human life. So, I arrested him as he violated Sec. 279 IPC and I also seized the motor cycle in presence of witnesses. His family member was also informed about the ground of arrest.


