Sub: Complaint against Dipak Singha (41 y), S/O- Lt. Durgaprasad Singha of Vill-Begunkdor PS - Kotshila, Dist - Purulia, to start a case U/S- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accd. Dipak Singha (41 y), S/O- Lt. Durgaprasad Singha of Vill-Begunkdor PS - Kotshila, Dist - Purulia with seizure of approx 11 (Eleven) liters illicit liquor from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (01.02.2022) during Special raid duty or. acting secret source information I held raid 05:35 hrs in the house of above noted person at Begunkodar village who was stocked illicit spirit in his house. I searched the place and found approx 11 (Eleven) Liters illicit spirit which was kept in a white colour Jaricane. On interrogation he disclosed his name and address as noted above and also stated that he use to sell the same for his gain in liu of money. On demand he failed to produce any valid documents in respect of illicit spirit which is kept in his house. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith in between 06:05 hrs to 06:25 hrs. As such he was arrested at 06:35 hrs U/S- 67 B.E. Act and during arrest the ground of arrest was duly notified issuing arrest memo U/S- 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 500 (Five Hundred) m.l was taken out in a separate container as sample with sealed & labeled.

The above noted arrested accd Dipak Singha (41 y), S/O- Lt. Durgaprasad Singha of Vill-Begunkdor PS - Kotshila, Dist - Purulia violate section 18 (i) B.E. Act. for possession and selling of intoxicating not obtained from a licensed vendor and in contravention and he Committed offence u/s 46 A (C) B.E. Act. 1909.

I: may note here that during raid (1) C/982 Shyamal Rajwar C/332 Ashok Kr. Kanduk JC/1389 Nilkanta Kumar accompanied me Vide Kotshila P.S C.C No 273/2022, Dated 01.02.2022.

Under the fact and circumstance I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against arrested accd person namely Dipak Singha (41 y), S/O- Lt. Durgaprasad Singha of Vill-Begunkdor PS - Kotshila, Dist - Purulia.
