


The above-named complainant/petitioner begs to state as follows:

1. That your petitioner/complainant residing at village- Begunkudor, P.S-Kotshila, Dist- Purulia, West Bengal, which is his paternal home. Witness no.2, witness no 3 and are the relatives of the petitioner/complainant. Witness no 4. And 5 are the villagers.

- 2. That on 07/01/2022, at about 9.30 to 10.30 am, Nityananda Dutta along with his two sons namely Dhananjay Dutta and Taraknath Dutta had entered the house of the complainant and started using abusive & offensive language mentioning to the father of the present complainant Manik Dutta.
- 3. That during that time the mother of the complainant came out and opposed the indecent behaviour of the above named accused as to why they are using such abusive and offensive language towards her nusband.
- 4. That on hearing such protect from the mother of the complainant, Dhananjay Dutta assaulted the mother of the complainant at her belly by his legs and because of such assault the complainant's mother fell down on the ground and then and there Nityananda Dutta pulled the complainant's mother by holding her hair and dragged her forcibly by the village kulli road.
- 5. That on hearing the hue and cry of the complainant's mother calling for help to relief herself from the deadly claws of the accused, the complainant and his father came out of their house and saw that her mother was being dragged in the middle of the village kuli road and she was being assaulted at various parts of her body by all the accused.
- 6. That when the present complainant and his father tried to rescue her from the deadly claws of the accused then Taraknath Dutta assaulted the father of the complainant over his head by "Bhujali", with an intention and motive to murder the complainant's father Manik Dutta. And on receiving such blow, Manik Dutta fell on the ground with bleeding over his head and sustained grievous injury over his head.
- 7. That when the complainant also tried to resist then all the accused persons also assaulted him with lathi as a result the complainant sustained internal body injury and Nityananda Dutta caught hold of him by his neck and tried to press to take his life. Any how the complainant managed to escape from the hands of the accused. That with the help of the local people the father of the complainant was taken to Deban Mahato Sadar Hospital where he was treated.
- 8. That all the accused are threatening the complaint and his family members. That this incident was reported at Kotshila P.S but the Police Station took no action against the accused persons.



- 9. That finding no other alternatives your petitioner has knocked the door of Superintendent of Police, Purulia on 13/01/2022 but nothing has been done from his end.
- 10. That your petitioner is a helpless woman having full faith in the justice delivery system of the country and for all these it is desirable and prayed that this case should be converted to a police case.

It is respectfully prayed that under such Circumstances and for the reasons stated above and for the ends of justice, You Honour may be graciously be pleased to direct the O/C Kotshila P.S to investigate the case by Treating the complaint as F.I.R as provided U/S-156(3) Cr.P.C. and in accordance with the law.
